## STATE CONTRACTORS BOARD

### MINUTES OF THE MEETING DECEMBER 9, 2003

#### 1. CALL TO ORDER

#### 1. DISCIPLINARY HEARING:

##### J Q CONSTRUCTION, LICENSE NO. 46712

Licensee was present.

Hearing Officer Cavin found the respondent John E. Qualtier, dba J Q Construction, license number 46712, guilty of the second, fifth and sixth causes of action and dismissed the first, third and fourth causes of action. Mr. Qualtieri was assessed a fine of \$250 per cause of action for a total of \$750. Investigative costs were assessed in the amount of \$689.50. The fine and costs are to be paid within 120 days from December 9, 2003 or license number 46712, J Q Construction will automatically be suspended. A current financial statement is to be furnished within 60 days from December 9, 2003 or license number 46712, J Q Construction will automatically be suspended.

#### 2. DISCIPLINARY HEARING:

##### W E BANASZAK, LICENSE NO. 54741

Licensee was present, with counsel, Eric Stovall.

Hearing Officer Cavin dismissed all causes of action against W E Banaszak, Wayne Ernest Banaszak, Manager, license number 54741.

**3. DISCIPLINARY HEARING:**

**CARLO CAMILO FIORI, LICENSE NO. 43455**

Licensee was not present. David Atkins, counsel for Licensee was present.

This matter was resolved. Hearing Officer Cavin informed Mr. Atkins that the Board would accept the voluntary surrender of Carlo Camilo Fiori, dba Carlo Camilo Fiori, license number 43455, once the financial settlement has been paid.

**4. NEW APPLICATION HEARING:**

**ABEL DOORS**

Applicant was present.

Hearing Officer Cavin denied the license application of Abel Doors, Jimmy Gettings, Owner.

**5. DISCIPLINARY HEARING - DEFAULT ORDERS:**

**a. WRIGHT WAY PAINTING, LICENSE NO. 52210**

Licensee was not present.

Hearing Officer Cavin found respondent Wright Way Painting, Pamela Sue Wright, President, license number 52210, in Default and adopted the Findings of Fact and Conclusions of Law as set forth in the Administrative complaint. License number 52210, Wright Way Painting, was Revoked. Ms. Wright is required to pay full restitution to the damaged parties and reimburse the Board for Investigative Costs of \$1,140, plus any expenses that may be paid out of the Residential Recovery Fund prior to consideration of future licensure.

**b. CP CONSTRUCTION, LICENSE NO. 52353**

Licensee was not present

Hearing Officer Cavin found respondent Gregory Donald Powell, dba CP Construction license number 52353, in Default and adopted the Findings of Fact and Conclusions of Law as set forth in the Administrative complaint. License number 52353, CP Construction, was Revoked. Mr. Powell is required to pay full restitution to the damaged parties and reimburse the Board for Investigative Costs of \$1,489, plus any expenses that may be paid out of the Residential Recovery Fund prior to consideration of future licensure.

There being no further business to come before the Board, the meeting was adjourned by Adjudicating Board Member Cavin at 10:58 a.m.
