



Contractor Alert On Possible Nigeria Bank Scam

The Nevada State Contractors Board (NSCB) has received information that letters and faxes from the Central Bank of Nigeria may be going out to Nevada Contractors asking for confirmation of bank account and other personal information.

The NSCB is issuing an alert to all contractors throughout the State of Nevada to be **cautious** of these letters and faxes.

Contractors are reminded that **any** personal or banking information could be used by persons engaging in identity theft.

Unlicensed Contractor Advertising In Local Telephone Directories

The Nevada State Contractors Board is warning contractors to be on the alert for an unlicensed company called **Electrical Specialists**, currently advertising its services in full-page advertisements in local telephone book directories in Southern Nevada.

Electrical Specialists has also been known to dispatch service personnel to homes using the name **Desert Lights Electrical**, a company that voluntarily surrendered its contracting license (*number 60758*) on Sept. 4, 2007.
