# Lien Waivers, Pay-If-Paid Struck By High Court

The Nevada Supreme Court recently published its decision in the case of Lehrer McGovern Bovis vs. Bullock Insulation, 124 Nev. Adv. Op. No. 39. In the Bullock case, the court tackled two issues critical for contractors: lien waivers and pay-ifpaid clauses. The court struck each

provision concluding that they "were unenforceable, based upon Nevada's public policy favoring the statutory right to a mechanic's lien."

The underlying facts are that Bullock entered into a subcontract with Bovis, which waived Bullock's lien rights regardless of whether Bullock received



any payment. Additionally, the subcontract provided that Bovis had no obligation to pay Bullock, if it had not been paid by the Venetian Hotel.

The court struck the lien waiver because a "contractor has a statutory right to a mechanic's lien for the unpaid balance of the price agreed upon for labor, materials, and equipment furnished." The court further reasoned that the purpose of the lien statutes are to secure payment to those who perform labor, or furnish material to improve property of an owner.

After tossing the lien waiver, the Court addressed the pay-if-paid provision. The court noted that Bullock's subcontract predated the 2001 enactment of NRS 624.624-626, which made pay-if-paid provisions unenforceable; but found that "because a pay-if-paid provision limits a subcontractor's ability to be paid for work

already performed, such a provision impairs the subcontractor's statutory right to place a mechanic's lien on the construction project." The court would not enforce the pay-if-paid clause because it would limit contractors' lien rights, which the court determined would violate Nevada's public policy of securing payment for contractors.

The Court concluded that not every lien waiver violates public policy, and each lien waiver must be analyzed on a case-by-case basis by considering whether the waiver fails to secure payment for contractors. It seems then that in Nevada, only lien waivers issued in exchange for payment are enforceable.

The Bullock decision has its critics. While it benefits some contractors, it puts higher-tier contractors in a financial vice between non-paying owners and unpaid lower-tier contractors or material-men.

Together, we can secure a future for Nevada not based on limitation, but unprecedented opportunity. But to do it, we must all work together . . . and it must start at the ballot box.


The races are close, and on Election Day your vote will make all the difference.

Pat's closest friends.

Pat, along with her husband, Ray, used to own the High Desert Racing Association. Every year, hordes of off-road racers competed in this organization's prestigious circuit series that crisscrossed some of Southern Nevada's roughest terrain. The SCORE racing association would eventually buy the race series from the Potters.

Surprised?

Wait - there's more!

Pat used to own Pat's Heavenly Creations, a country store/antique shop on Decatur Boulevard, located between Lake Mead Boulevard and Rancho Road in Las Vegas. Stuffed dolls were her specialty, including one cute little honey bear that the Disney Corporation found to be one of its top sellers.

Pat came to Las Vegas in 1957 in an old 1936 Ford. Back then, there were only three high schools in Clark County – Gorman, Basic and Las Vegas High School, where Pat graduated from in 1961. She met her husband when he bought that old family Ford.

"My mother said that I came with the car," Pat says with a little laugh and fond twinkle in her eye. "Since we have been together, it has been cars in one form or another."

Born and raised in Las Vegas, Ray used to own Las Vegas' iconic 5<sup>th</sup> Street Liquor. The Potters donated this favorite local watering-hole neon sign to The Neon Museum a couple years ago, which the historical organization quickly put on display in the downtown Las Vegas Fremont Street Experience. Ray also used to own Ray's Beaver Bag, another Las Vegas landmark that specialized in black-powder guns, knives, teepees, cast iron cookware, etc.

"It was like an old general store," Pat remembers. "Something mountain men would like."

To this day, Ray occasionally hangs out with his buddies at mountain-men wilderness outings – but not Pat.

"My idea of camping is staying at the Hilton, and not in some teepee," she says with a laugh.

Pat retired from the Board in July 2008, after 15 years of service.

They plan to enjoy their retirement taking part in various Horseless Carriage Club of America car outings and an occasional vintage auto parade.

The Potters also will relish being able to spend more time with their four daughters: Dawn; twins Shiela and Sheryl; Carolyn and six grandchildren, Ashlin, 22; Morgan, 15; Katie, 5; Aaron, 19, Zack, 11; and Robbie, 7. Pat and Ray, unlike many American families, are fortunate to have all their children and grandchildren living in Southern Nevada.

"The Board is a wonderful organization to work for," Pat says. "Management is very good to its people. I will miss everyone terribly."

To this day contractors, who Pat helped when she was a license analyst, call her when they have questions.

"I like helping people," Pat says. "I did this for so many years with racing. It's just something I enjoy doing. You have to remember that you are dealing with people's livelihoods (when they apply for a contractor's license). I always ask myself, 'Would I want to have this person do work in my daughter's home?' It is a huge responsibility to sign off on a person's application."

When Pat started at the Board, the staff was small and each licensing analyst did everything from taking in new applications to recording address changes and processing renewals and officer changes. Back then, she was in charge of contractors whose names began with the letter A. When she retired, Pat was supervising a staff of 14 employees.

"I think you have to listen to each of them (the analysts), and you have to be fair," Pat says with the voice of a mentor. "And you need to give them direction."

# <u>Company Profile</u> Hoolihan's Excavating: A Company Built On Hard Work

One may

ask how someone can build a successful company. For Jon Hoolihan, owner of Hoolihan's Excavating, Inc., the answer is simple. Hoolihan

attributes the success of his company to hard work and dedication.

His company just celebrated its

30<sup>th</sup> anniversary, but before Hoolihan opened his own company, he worked for different contractors in Las Vegas, including Acme Electric where he was a backhoe operator.

"I always wanted to be in business for myself," Hoolihan says. "I didn't have a lot of money, but I bought a backhoe, and it was exciting." Before obtaining his contractor's license, Hoolihan worked extremely hard but really enjoyed the type of work he did.

"At that time, I truly...worked seven days a week, 17 hours a day, and then I studied at night to get my contractor's license," he says. His wife ran the business from their home when they first started. Now, Hoolihan employs 20 people.

Hoolihan says his company specializes in underground dry utilities, such as power, telephone, cable television and street lights.

Over the years, rules have changed in his industry. Construction-defect cases concern him the most. Even though his company was never found in violation of construction-defect laws, he says these cases have cost his company a great deal of money and



raised his insurance rates.

In general, if problems arise on the job, they are fixed immediately. "We're a legitimate company, and if something goes wrong, you call us up, and we'll go fix it...It doesn't matter what it costs, we'll make sure it's done right," Hoolihan says.

At Hoolihan's Excavating, Inc., safety is the No. 1 priority. Hoolihan says they have safety meetings every week. "We realize this is a dangerous business, and we let our guys know it's a dangerous business." As a result

of their regularly scheduled safety meetings, they haven't had any employees seriously injured on the job.

Quality and timeliness is very important to Hoolihan's Excavating, Inc. Employees are expected to perform their jobs as if it were their

own project. And it is also important that customers are taken care of in a timely manner, Hoolihan adds.


Hoolihan recommends that contractors "be fair, honest and do a good job." During these tough



economic times, some contractors who find it hard to find work, may resort to performing work below cost to make equipment payments. It is important for

contractors to make a little profit, Hoolihan says. Even if we are encountering economic hardships, Hoolihan says, "Keep on bidding, and you'll get one. And if you get them all, you're in trouble. You're bidding too cheap." He also recommends that contractors constantly be actively searching for jobs.

"This is a very fun, interesting field that we're in, and it's exciting," he says. In the future, Hoolihan plans on expanding his family-owned business. He also hopes that one day his nephew will take over his company.

# <u>3rd Annual Mission Cool Off Program</u> Five Families Receive Free Air Conditioners

The 3rd Annual Mission Cool Off Program helped five households this year. This annual program is co-sponsored by the NSCB and the Southern Nevada Air Conditioning Refrigeration Service Contractors Association (SNARSCA). Every year, homeowners are chosen to receive new air conditioners based on their special circumstances.

Rena Gorre, 79, was one of three homeowners selected this year. "I'm happy, and I can't wait to hear it turn on," Gorre said after receiving her new unit. She suffers from kidney disease and has been on dialysis for nearly 2½ years.

Gorre's daughter, Deborah Strangfeld, 50, suffers from asthma and has a spinal cord disability. "We couldn't afford to buy a unit ourselves," Strangfeld says. Her 40-year-old AC unit came with the house.

Tony Hernandez, install supervisor for Sun Country Heating and Cooling, supervised Gorre's installation. "We like to help the community," Hernandez says, adding that his company participates in the program every year. "You sleep better...knowing that you're honest, and...helped someone out."

Another recipient of a new unit was Patsy Pope, 49, who heard about Mission Cool Off on television. She was very surprised to be chosen. "I just didn't think that I was going to be...one of the chosen," Pope says.

Pope recently lost her full-time job of

19 years, but was called back on a part-time basis. She is a single parent who takes care of her daughter and two granddaughters.

"I am very thankful," she says. "I really didn't think that people really cared in the community. When this happened to me, it showed me people do care."

Troy Putman, service manager for Sierra Air Conditioning and vice president of SNARSCA, assisted with the installation of Pope's new air conditioner. "Our owner (has) been a very big supporter of SNARSCA and any program that we're involved in. And they always want to give back to the community," Putman says.

The best part of helping others,

Putman says, is the personal contact he has with them. He enjoys seeing people's joy after being helped.

The third person chosen was 72-yearold Kathleen Ludyen. Ludyen lives on a fixed income, so she couldn't afford to replace her old unit. She was injured on the job and is limited in the types of jobs she can perform. When Ludyen was chosen for the program, she said, "I was just overwhelmed and very grateful, very grateful."

"I can't tell you how grateful I am that I got this because I just had a knot in my stomach thinking about the whole summer coming up and being hot, and then everybody was so nice about...

CB/A: Commercial development in Nevada never really experienced the slowdown that residential development did? Why is that? And should commercial developers take heart of what happened in the residential arena for fear that the same thing might happen to them?

*KG:* This is not right. The Commercial side of Nevada has had several slowdowns, 1968-1973, 1982-1986, 1992-1994 and 2001-2003. Nevada is subject to the same national issues as every other state.

The bigger we get, the more that will be the case. The financing for the casino industry has always been ever-changing and difficult. Growth is the issue, and it will affect both commercial and residential, but probably not at the same time.

**BK:** Commercial will follow housing. It's not overbuilt as housing is/was, but commercial construction always follows residential rooftops. If housing picks up in the next year, I'm hopeful the downturn in commercial construction will not be too deep.

*MC:* In Northern Nevada, commercial development is still catching up with the residential boom. I believe that commercial building will continue at a steady pace with no slow down in sight. With current interest rates, commercial/industrial development is very attractive.

# **Commercial Builders Give Advice On Conducting Business**

#### Reprinted From Spring/Summer '08 Commercial Builder/Architect Magazine

Many people are closely monitoring the commercial real estate environment throughout Nevada, clearly one of the healthiest markets in the nation. Commercial Builder/Architect Magazine recently sat down with three of Nevada's most successful commercial developers, Margaret Cavin of J & J Mechanical Inc. in Sparks, Bruce King of Pete King Nevada Corp. in North Las Vegas and Kim Gregory of Hansen Mechanical Contractors Inc. in Las Vegas. Cavin and King are current Board members of the Nevada State Contractors Board, and Gregory is a former Board member.

Commercial Builder/Architect: What is the best advice you can give commercial contractors before they start a project in Nevada?

*Kim Gregory:* Make sure your contractor license and all necessary business licenses are current. Review the Nevada State Contractors Board's laws, if you are an out-of-state contractor. The laws include



Chapter 624 of the Nevada Revised Statutes, and the Nevada Administrative Code. Have your Nevada contractor's license <u>before</u> biding on any work.

#### Bruce King:

Understand, bid and plan to build per plans and specifications. Few building departments in the country are as particular as the Clark County area.



CB/A: What advice can you give in dealing with the Nevada State Contractors Board?

*KG*: Always tell the truth and be straight up with the Board.

*BK:* Staff and Board are very helpful. The key is to make requests early and timely.

#### Margaret Cavin:

Once a contractor is licensed in Nevada, most will probably have minimal dealings with the Board. I would suggest to any contractor to take advantage of the Contractors Board's

website. It is a great resource tool. I personally use it all the time.

### CB/A: What misconceptions, if any, do general contractors and subcontractors have both before starting a commercial project and also during its development?

*KG:* That they will always be paid on time or even paid at all. Read your contract and check out the owner or developers. Check both the banks and/or financing on the project. Make sure to verify all subs are licensed prior to issuing any subcontracts.

*BK:* Too many assumptions. Documentation is important and can save tremendous costs and headaches.

#### CB/A: What have been some reoccurring issues concerning commercial development that has come before the Board?

*KG:* Proper license limits and classifications. Ask the Board to explain the license classification, if there are any questions or concerns.

**BK:** Bidding beyond their limits, and late requests for one-time increases in limits.

#### **CB/A: Before bidding on a project,** what should commercial contractors keep in mind?

*KG:* Do they have the proper financial backing to do the job? Can they pay their bills and others for 90 days without receiving any payment? Nevada law does

not allow certain down payments. Make sure they file pre-lien notices, as required by law. Again, read the contract before signing it.

*BK:* Be realistic with your experience and abilities.

# **CB/A:** You are all successful commercial contactors. In your opinion, what made you so successful?

*KG:* Dealing with qualified owners, projects and general contractors. Again, being upfront and honest with people. Making sure my company and my people perform as expected.

*BK:* A good reputation for completing quality work, a desire to satisfy our customer and COLLECTING MONEY OWED TO US.

CB/A: What are some common issues contractors need to address when dealing with OSHA? The Contractors Board? The various county and city permitting departments?

*KG:* Communication with any government agency is the most important issue that I've seen in the past. Safety people have to stay informed on OSHA's ever-changing requirements and regulations. Trade organizations and contractors need to be aware of the Contractors Board's issues and changing requirements and or problems. The same thing exists regarding the various building departments, which is even more confusing due to the independent nature of each different city or county you are dealing with.

**BK:** When there are issues, and there will be if a contractor does a fair amount of work, easy communication (they know who in your company they need to deal with and that person follows up without additional work on their part) and a commitment to quickly resolve the problem is important.
