In the months to come, we will further our initiatives to protect the public as we meet with the Clark County District Attorney's Office new elder abuse prosecution unit to discuss the Board's investigative cases against rogue contractors who prey on the elderly. We look forward to an enhanced and expanded partnership with the D.A.'s Office that will lead to greater penalties for those individuals who purposefully take advantage of our most valuable citizens.



**Financial Responsibility Hearing Outcomes** 




#### **Separate License Required** For Mobile Home Work

Pursuant to NRS 624.215 and NRS 489.311, a license from the Manufactured Housing Division is required for this work. Working on a manufactured structure/mobile home without a Manufactured

> Housing Division Serviceperson license is unlawful and may result in disciplinary action against businesses and each individual lworker.




### **Enforcement - Unlicensed Contractors**

NSCB's Criminal Investigations Division responds to all unlicensed contractor complaints. After gathering evidence, the Board submits cases to the district attorney, who may file and prosecute misdemeanor, gross misdemeanor or felony charges.

### License revoked for multiple violations

The Board revoked the license and assessed \$60,000 in fines to Creative Interior Solutions after finding the company in violation of several regulations and statutes, including substandard workmanship, failure to take corrective action, failure to prosecute a construction project with reasonable diligence, causing material injury, abandonment of a construction project when the percentage completed is less than the percentage

of the contract price received, willful disregard for the state's building laws, failure to respond to a written request from the Board, failure to comply with a request from the Board for information or records, failure to comply with terms or a contract or warranty, causing material injury, abandonment of a construction project without legal excuse, and failure to establish financial responsibility.

## Sting cites 18 unlicensed contractors

The Nevada State Contractors Board cited 18 suspected unlicensed contractors during sting operations in Sparks on September 25 and Henderson on September 29. Investigators identified suspects through complaints to the Contractors Board and by examining advertisements on Craig's List and other bulletin board services.

In Henderson, undercover investigators issued citations to 12 suspects. Seven were ordered to appear in court to answer charges of contracting without a license and advertising construction services without a contractor's license. Five were ticketed for unlicensed

advertising. Among these, Salvador Ulloa-Gutierrez fled the scene, and two others failed to show up for their meeting at the sting house. The Board has filed affidavits with the district attorney's office to obtain warrants for their arrest on advertising charges.

In Sparks, three suspects were cited both for allegedly contracting without a contractor's license, a violation of Nevada Revised Statutes Chapter 624.700, and allegedly advertising without a contractor's license (NRS 624.720). One was cited for contracting without a license, and two were charged with illegal advertising. Two of

those cited are former Nevada licensed contractors whose licenses have been revoked within the last four months.

"The participation of the entire legitimate construction and development profession is instrumental in bringing the scourge of unlicensed contracting under control," said NSCB Executive Officer Margi Grein. "We are also proud of the cooperation we received from the both the Sparks and Henderson Police Departments. The presence of police officers during these operations sends a strong message that law enforcement across the board considers unlicensed contracting activities

### Board investigation nets felony arrest

The subject of numerous and lengthy Nevada State Contractors Board investigations, Michael Delbridge was sentenced in August to 12 to 48 months in prison for felony contracting without a license. The sentence was suspended, and Delbridge was placed on probation for up to five years.

Delbridge, who pleaded guilty on April 22 to felony charges of engaging in business without a license, contracted for construction projects under the names "Southwest Construction," "Roadrunner Construction," and "Michael Delbridge Construction." His activities have drawn the Contractors Board's attention at various times since 1994. He has faced allegations of posing as a licensed contractor, obtaining funds under false pretenses, diversion of funds and victimizing vulnerable persons.

In the most recent case, Delbridge was arrested at the NSCB office on a felony warrant. Board investigators delivered evidence to the Clark County District Attorney's Office, which then submitted five cases resulting in a felony conviction, including restitution to five homeowners and investigative costs to NSCB. Since Delbridge's plea in District Court, NSCB criminal investigators have received five additional complaints. In one case, Delbridge entered into the construction contract after his court appearance. Delbridge has amassed 17 cases at NSCB with additional charges pending as a result of the five new complaints.

"Repeat offenders, such as Mr. Delbridge, who continuously place homeowners at risk because of their unlicensed contracting practices are a serious threat to the public's safety," stated Executive Officer Margi A. Grein. "It is always a good feeling when you can partner with other agencies like the Clark County District Attorney to bring these individuals to justice and hopefully deter

future harm from being done."

Investigators determined Delbridge offers a bid and entices the victims to pay cash up front by claiming his "vendors" are offering a sale. The victims believe they are getting a deal. Delbridge will sometimes begin the project and then stop appearing at the victim's home.

When the victim calls regarding the project, Delbridge claims problems with his health, vehicles or other projects. When the frustrated homeowner requests a refund, Delbridge continues to make excuses, sometimes giving a partial payment. However, when the remainder of the funds are requested, Delbridge promises to get back to work, claims the bank won't release the funds, and takes other measures to delay the project.

When left with no choice but to refund a victim's cash, Delbridge often starts another project and uses the new victim's down payment to pay back the previous victim.

serious threats to the safety and welfare of Nevada's citizens."

In both investigations, Board investigators posing as property owners contacted unlicensed contractors, inviting them to visit the sting location to discuss performing floor tile installation, landscaping, drywall, painting and plumbing work. According to Nevada law, all electrical, plumbing, air conditioning and heating work must be performed by licensed contractors. All other work requires a license if the cost of the project – labor and materials – totals \$1,000 or more or requires a building permit. It is against the law to advertise

to perform any trade for which the Board issues licenses.

The Board's criminal investigators conducting stings use the interactions to encourage unlicensed contractors to obtain their contractor's licenses while also fulfilling the Board's mandate to protect the health, safety and welfare of the public.

# NSCB finds fraud, revokes license

A North Las Vegas contractor has been assessed \$146,500 in fines and fees after pleading *nolo contendere* in a fraud case brought by the Nevada State Contractors Board. Recreation Development Co. (RDC) license numbers 73558 (general building), 44802 (commercial and residential pools), 47622 (painting and decorating), 47623 (building facades) were suspended and eventually revoked. In addition, the company's principles – Jeffrey Whittle, Shelley Whittle and Albert Nelson, Jr. – are prohibited from seeking new Nevada contractors' licenses for at least 10 years.

"The Board is becoming more aggressive in its efforts to investigate cases of construction fraud," noted NSCB Executive Officer Margi Grein. "We hope the outcome of this case sends a clear message to the industry that we take our mission to protect the health and safety of the public seriously and will not tolerate fraudulent activities."

Administrative Law Judge Phillip Pro presided over the case in which Jeffrey Whittle and Nelson, Jr. entered the pleas on 13 charges including three counts of committing a fraudulent

and deceitful act, misrepresentation of a material fact, failure to comply with a written request from the Board, four counts of failure to keep records of a construction project for at least three years, failure to include the license number and monetary limit on a contract, acting in the capacity of a contractor using company names not on the license and failure to establish financial responsibility.

The Board initiated an investigation after receiving a complaint from a company that built an \$11.7 million project in North Las Vegas in 2011. The developer alleged that its general contractor, RDC, and its project manager were using false invoices to defraud the developer into paying for work never performed. The company became suspicious after communicating with several people claiming to have knowledge of fraudulent acts committed by RDC and the project manager. Board investigators spent over ten months investigating the case and reviewed over 11,000 pages of records. Fraudulent billings for approximately \$300,000 were identified and traced back to some of the principles of RDC.

# Leggett elected Board chairman

At its July 23 board meeting, Jan Leggett was elected to serve as chairman and Margaret Cavin was elected to continue her role as treasurer. Leggett succeeds Guy Wells who served as chairman since July 2012.

"On behalf of the Contractors Board, I wish to extend our congratulations to Mr. Leggett and Ms. Cavin on their recent election, and to thank Mr. Wells for his leadership as chairman these last few years," stated NSCB Executive Officer Margi Grein.

Leggett was appointed to the Board by Governor Brian Sandoval in November of 2012. He is a manager and qualified employee with Moana Nursery in Reno. He is past president of the Northern Nevada Landscape and Irrigation Council and chairperson of the Government Affairs Committee of the Northern Nevada Associated General Contractors.

Margaret Cavin was first appointed to the Board in January of 2000 and during her tenure was elected the first woman to serve as Chair. She is co-founder of J & J Mechanical Inc. with 30 years' experience in the construction industry, and past President of the Nevada Chapter of the Associated General Contractors.

#### New licensee revoked after six months

In August, a disciplinary hearing was held for Epcon Electric Nevada, LLC, license number 79838 (electrical), after three complaints were received by the Board. Having only been licensed since February of 2015, Epcon Electric Nevada, LLC quickly found themselves in hot water, having their license summarily suspended after a number of concerning allegations were being investigated by the Board.

At the conclusion of the hearing, Epcon Electric Nevada, LLC, stipulated to the revocation of

its license based on 18 causes of action, including violations for acting in the capacity of a contractor without an active license, acting in the capacity of a contractor under a license issued in a name other than the licensee's, diversion of funds, misrepresentation or omission of a material fact in order to obtain a license, failure to establish financial responsibility.

The now revoked licensed contractor is ordered to pay fines and costs totaling over \$12,000.

### Be a "card-carrying" licensed contractor

The Nevada State Contractors Board continuously reminds property owners to check contractors' pocket identification cards before agreeing to proposals, signing contracts or allowing anyone to perform work on their homes or businesses.

As these outreach efforts continue, NSCB also encourages all licensed contractors to carry the pocket cards while on the job and especially in situations where they think they might be soliciting business or.

The hard plastic license pocket cards recently were redesigned to include NSCB's logo and the state seal in addition to the license number, business name, classification(s), and license expiration date. One card is issued upon issuance and renewal of the license. NSCB allows con-

The following information is provided to help Nevada Contractors work within the law. Always make sure license number and monetary limit is on all contracts or bids. NAC 624.640(5)
Keep your bond current. NRS 624.270
Check to ensure that licenses or persons with whom you contract are valid and active. NAC 624.650
Be sure name of business under which contractor is contracting is the same as the license number. NRS 624.305
Be sure the amount of the bid or contract is within the monetary limit of the contractor. NRS 624.3015(2)
Be sure that the contract is within the scope of work/license classification. NRS 6243015(3)
Know what you are contracting for, verify terms of the contract, and comply with terms of the contract. NRS 624.3013(1)
If it is not in your written contract, it doesn't exist. Make sure all change orders are in writing and signed by all parties. NRS 624.3013(1)
Include Residential Recovery Fund Disclosure on all residential contracts. NRS 624.520
Provide customers with required Notice to Owner Disclosure. NRS 624.600(1)(2) and (3) as described in NAC 624.693 & NAC 624.6932
Make sure your license number is on all business advertisements, including vehicles, business cards, letterhead, signage, directories, newspapers, website, etc. NRS 624.720
Always make sure license number and monetary limit is on all contracts or bids. NAC 624.640(5)
Your license number should be approximately 1 1/2 inches on your motor vehicle. NRS 624.288
If your address or other pertinent information about the business changes, notify Contractors Board in writing within 30 days. NAC 624.640(3)

# Board revokes, fines licenses

**RENO and HENDERSON, Nev.** – The Nevada State Contractors Board took action against several licensed contractors at its July, August and September disciplinary hearings:

James E. The license was revoked. Licensee was fined \$60,000 and assessed investigative costs.

**Road Work Ahead, Inc.,** license number 73883 (sealing and striping of impermeable pavement), based out of Las Vegas, Nev., was found in violation for failure to establish financial responsibility and failure to keep in force a bond or cash deposit. 
