## CONTRACTORS BOARD TAKES DISCIPLINARY ACTION AGAINST NINE CONTRACTORS

(*Henderson*, *NV*) - At its meeting on February 24, 2004, the Nevada State Contractors Board adjudicated cases against nine (9) licensed contractors.

*Floor Specialist, Inc. dba Specialized Flooring,* license number 44466A (Finishing Floors) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for contracting or bidding with a suspended license; misrepresentation of a material fact; failure to provide required disclosures. The Board revoked the license of Floor Specialist, Inc. dba Specialized Flooring.

Ronald Colin James dba Miscellaneous Services, license number 45348 (Landscape/Irrigation) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for substandard workmanship; acting in the capacity of a contractor beyond the scope of the license; willful disregard of state building laws; and combining with a unlicensed person. A permanent letter of reprimand was placed in licensee's file. Licensee was fined \$1500 and assessed the cost of investigation and required to retake the business law exam.

**Robert Amador Chavira dba All Pro Concrete,** license number 50784 (Concrete Contracting) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for substandard workmanship; failure to comply with a notice to correct; failure to establish financial responsibility; failure to provide required Residential Recovery Fund disclosures; failure to pay for materials or services; failure to cooperate in the investigation of a complaint; and diversion of money or property. The Board revoked the license of Robert Amador Chavira dba All Pro Concrete.

Foliage Unlimited Landscaping LLC, license number 51274 (Landscape Contracting) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for substandard workmanship; failure to comply with a notice to correct; combining with an unlicensed person; acting in the capacity of a contractor beyond the scope of the license; failure to provide required disclosures for pool contracts; failure to comply with pool contract regulations; failure to comply with pool contracting laws; and failure to include license number and monetary limit on a contract or proposal. The Board revoked the license of Foliage Unlimited Landscaping LLC.

*Wayne Harvey Forster dba 21<sup>st</sup> Century Roofing*, license number 44350 (Roofing) base out of Encino, California was found in violation of Nevada Revised Statute 624 for failure to pay for materials and services; failure to establish financial responsibility; substandard workmanship; failure to comply with a notice to correct; failure to provide Residential Recovery Fund disclosures; and failure to comply with the terms of a contract or written warranty. The Board revoked the license of 21<sup>st</sup> Century Roofing.

Environmental Landscape Designs Inc., license number 44736 (Landscape Contracting) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for combining with an unlicensed person to commit an unauthorized act; disregard of state building laws; acting in the capacity of a contractor beyond the scope of the license; failure to provide required Residential Recovery Fund disclosures; bidding or contracting in excess of established license limit; and contracting under a name other than that set forth on the license. The Board revoked the license of Environmental Landscape Designs Inc.

**Paving Stone of Nevada Inc.**, license 51002 (Masonry) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for abandonment of a construction project; failure to establish financial responsibility; failure to cooperate in the investigation of a complaint; failure to include license number and monetary limit on a contract or proposal; failure to provide required Residential Recovery Fund disclosures; failure to report to the Board a change in address or personnel; failure to obtain appropriate lien releases; and failure to include license number and monetary limit on a contract or proposal. The Board revoked the license of Paving Stone of Nevada Inc.

**Bubba Brick Company LLC**, license number 52179 (Masonry) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for failure to pay for materials and services; failure to establish financial responsibility; failure to cooperate in the investigation of a complaint; and failure to keep in force a bond or cash deposit. The Board revoked the license of Bubba Brick Company LLC.

Glass Systems Inc., license number 24239 (Glass and Glazing) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for failure to establish financial responsibility; failure to cooperate in the investigation of a complaint; failure to report to the Board a change in address or personnel; and failure to notify the Board of a petition of bankruptcy. The Board revoked the license of Glass Systems Inc.

The Nevada State Contractors Board is committed to protecting the public's health, safety, and welfare through licensing and regulation of the construction industry. Under Nevada Revised Statutes, a licensee is subject to disciplinary action by the Board for failure to comply with the requirements of the laws or regulations governing contractors. Violations may result in Board action against the contractor's license. The State Contractors Board has the power to regulate contractors and discipline licensees who violate NRS 624. Disciplinary action may consist of a fine of up to \$10,000 per offense, order corrective action, suspension, revocation or other action.

The Board will convene next in Reno, NV on March 9, 2004.
