## **NINE NEVADA CONTRACTORS DISCIPLINED** **BY CONTRACTORS BOARD**

(Henderson, NV) – At its meeting on Oct. 20, 2010, the Nevada State Contractors Board adjudicated cases involving nine contractors.

---

*Nevada Garage Cabinets, LLC., dba 1st Choice Storage Solutions*, license numbers 59785 and 54686 (Painting and Carpentry), based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for failure to establish financial responsibility and for the partnership, corporation, firm or association participating in a prohibited act. The licensee was fined \$250 and ordered to pay investigative costs. The licenses were suspended until a current financial statement is provided that supports the license limits.

*Bell Electrical Systems, LLC.*, license number 58771A (Electrical Contracting), based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for misrepresentation of a material fact. The licensee was fined \$2,500 and ordered to pay investigative costs. The license was placed on probation for one year.

*CY Chaim Yehros, dba C Y Development & Construction*, license number 16728 (General Building), based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for failure to pay money due for materials or services. The licensee was fined \$1,000 and ordered to pay investigative costs.

*ACDC Electrical Contractors Nevada, LLC.*, license number 73302 (Electrical Contracting), based out of Cedar City, UT, was found in violation of Nevada Revised Statute 624 for failure to respond to a written request from the Board; failure to establish financial responsibility; failure to comply with the terms of a construction contract, thereby causing material injury to another; abandonment of a construction project; failure to complete a construction project in accordance with the plans and specifications; and failure to pay money due for materials or services. The licensee was fined \$4,500 and ordered to pay investigative costs and make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund. The license was revoked.

***First Choice Electric, dba Las Vegas Sight & Sound***, license number 53676 (Electrical Contracting), based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for failure to comply with the terms of a construction contract, thereby causing material injury to another; failure to take appropriate corrective action; failure to include the Residential Recovery Fund information on a contract or proposal; failure to include the monetary license limit and license number on a contract or proposal; and failure to establish financial responsibility. The licensee was fined \$2,350 and ordered to pay investigative costs and make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund. The license was revoked.

***Access Technologies Corporation***, license numbers 46441 and 46442 (Fire Detection, Low Voltage, Structural Steel, Ornamental Metal, Prefabricated Steel Structures and Awnings & Louvers), based out of Henderson, NV, was found in violation of Nevada Revised Statute 624 for failure to establish financial responsibility and for the partnership, corporation, firm or association participating in a prohibited act. The licensee was fined \$500 and ordered to pay investigative costs and make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund. The licenses were revoked.

***R S V P Systems***, license number 52374 (Fire Detection and Low Voltage), based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for failure to establish financial responsibility. The licensee was ordered to pay investigative costs and make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund. The license was revoked.

---

***Anaya Construction, Inc.***, license number 50965 (Concrete Contracting), based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for failure to respond to a written request from the Board; failure to notify the Board of a bankruptcy and failure to establish financial responsibility. Due to the bankruptcy, no fines or investigative costs were assessed. The license was revoked.

***I Development Construction Corporation***, license numbers 69136 and 70312 (Residential & Small Commercial and Plumbing & Heating), based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for failure to respond to a written request from the Board; failure to establish financial responsibility and for the partnership, corporation, firm or association participating in a prohibited act. The licensee was fined \$1,000 and ordered to pay investigative costs and make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund. The licenses were revoked.

**\*\*The Business Review Program is one in which a contractor's business practices and regulatory compliance is examined by NSCB investigative staff. The program is a part of NSCB's proactive investigative efforts.**

***The Nevada State Contractors Board is committed to protecting the public's health, safety, and welfare through licensing and regulation of the construction industry. Under Nevada Revised Statutes, a licensee is subject to disciplinary action by the Board for failure to comply with the requirements of the laws or regulations governing contractors. Violations may result in Board action against the contractor's license. The State Contractors Board has the power to regulate contractors and discipline licensees who violate NRS 624. Disciplinary action may consist of a fine of up to \$10,000 per offense, order corrective action, suspension, revocation or other action.***
