**NOTICE OF INTENT TO ACT UPON A REGULATION**

**LCB File No. R119-23**

Notice of Workshop and Hearing for the Adoption, Amendment and Repeal of Regulations  
of  
The Nevada Commission on Construction Education

**The State of Nevada Contractors Board (Board) will conduct a public workshop on Thursday February 1, 2024 at 1:00 p.m. and a public hearing on Thursday, February 15, 2024 at 1:00 p.m. The workshop and hearing will be video-conferenced between the Board's Las Vegas office located at 8400 West Sunset Road, Suite 150, Las Vegas, Nevada 89113 and the Reno office located at 5390 Kietzke Lane, Suite 102, Reno, Nevada, 89511**

The following information is provided pursuant to the requirements of NRS 233B.060 and 233B.0603:

- 1. The need for and purpose of the proposed regulation or amendment.**  
The Commission proposes amendments to the Administrative Code to provide clarity regarding the entity types eligible to apply for a grant.
- 2. Either the terms or the substance of the regulations to be adopted, amended or repealed or a description of the subjects and issues involved.**  
A copy of the proposed amended regulation is attached to this notice.
- 3. The estimated economic effect of this proposed regulation on the business which it is to regulate and on the public.**
  - (a) Adverse and beneficial effects.**  
The Commission does not regulate business, therefore, there is no estimated economic effect. No economic impact is estimated to affect the public.
  - (b) Both immediate and long-term effects.**  
There are no immediate or long-term effects.
- 4. The methods used by the agency to determine the impact on small business.**  
No adverse economic effects were determined based on the proposed regulation changes.
- 5. The estimated cost to the agency for the enforcement of the proposed regulation.**  
There is no cost to the agency.

The Commission is not aware of any similar regulations of other state or government agencies that the proposed regulations overlap or duplicate.

**PROPOSED REGULATION OF THE NEVADA COMMISSION ON CONSTRUCTION EDUCATION**

**LCB File No. R119-23**

AUTHORITY: NRS 624.570(6)(7);

A REGULATION relating to the Commission; revising provisions governing entities eligible to apply for a grant; and providing other matters properly related thereto.

**Legislative Counsel's Digest:**

Existing law. . .

**Sec. 1. NAC 624.840 is hereby amended to read as follows:**

NAC 624.840 Application for grant from Account: Requirements; review by Commission; notice of disposition; request for reconsideration. ([NRS 624.570](#))

1. A ~~[school district in this State or a program of education that has been approved by the Commission]~~ *registered 501(c)(3) nonprofit agency, nonprofit educational institution, or governmental entity* may file an application, on a form provided by the Commission, for a grant of money from the Construction Education Account.

2. An application must be received by the Commission before the deadline established by the Commission and must contain:

- (a) The full name, address and telephone number of the applicant.
- (b) The full name and telephone number of the fiscal agent or fiscal manager of the applicant.
- (c) The following information, supported by appropriate documentation, concerning the qualifications of the applicant to receive a grant pursuant to this section:

(1) The applicant's strategies to increase enrollment in programs of education which relate to building construction.

(2) The applicant's strategies to increase awareness concerning the advantages of employment in the construction industry.

(3) The applicant's plan for statewide dissemination of project objectives.

(4) An outline of the applicant's program of education.

(5) The proposed expenses of the applicant.

(6) Any other information requested by the Commission to ascertain the qualifications of the applicant to receive a grant pursuant to this section.

3. An application and all supporting documentation must be notarized.

4. The Commission will meet semi-annually to review and rate applications. The Commission will review and rate each application on a "review rating form" created by the Commission. The "review rating form" must rate the application based upon the proposals of the applicant to meet planning criteria, goals and benchmarks, and budgetary requirements.

5. Not later than 10 working days after the Commission reviews and rates an application, the Commission will notify the applicant of the disposition of the application.

6. If an application is denied by the Commission, the applicant may, within 30 days after the date on which the application is denied, submit a request for reconsideration of the application by

the Commission. Within 30 days after receipt of a request for reconsideration, the Commission will:

- (a) Reconsider the application;
  - (b) Determine whether to affirm the denial of the application or to approve the application;
- and
- (c) Notify the applicant of the disposition of the request for reconsideration.

## Small Business Impact Statement

EFFECTIVE DATE OF REGULATION:

**Proposed Regulation R119-23**

### 1. Background

The Commission on Construction Education (CCE) proposes amendments to the Administrative Code to define types of entities that can apply for grants.

### 2. Description of Solicitation:

The CCE has determined that the proposed regulation changes should not have an adverse financial impact upon a small business; therefore, a solicitation process was not entered into. The proposed regulation changes are not expected to negatively impact the formation, operation, or expansion of a small business in Nevada.

### 3. Does the proposed regulation impose a direct and significant economic burden upon a small business or directly restrict the formation, operation or expansion of a small business?

Pursuant to NRS 233B.0608, the CCE made a concerted effort to determine whether the proposed regulation was likely to: 1) impose a direct and significant economic burden upon a small business, or 2) directly restrict the formation, operation, or expansion of a small business. As a result of this effort, the CCE determined that there is no impact upon small business as a result of the proposed regulation.

### 4. How was that conclusion reached?

No adverse economic effects were identified because the proposed regulation changes do not adversely affect NRS Chapter 624 licensees or those who may seek to become a licensee. These changes should have no impact on small business.
