NOTICE OF INTENT TO ACT UPON A REGULATION

Notice of Workshop and Hearing for the Adoption, Amendment or Repeal of Regulations of

The State of Nevada Contractors Board

LCB File R095-12 and R096-12

The State of Nevada Contractors Board (Board) will conduct a hearing on <u>Thursday, March 13, 2014 at 9:00 a.m.</u> The hearing will be video-conferenced between the Board's Henderson office located at 2310 Corporate Circle, Suite 200, Henderson, Nevada 89074 and the Reno office located at 9670 Gateway Drive, Suite 100, Reno, Nevada, 89521.

The following information is provided pursuant to the requirements of NRS 233B.060 and 233B.0603:

1. The need for and purpose of the proposed regulation or amendment.

The purpose of the proposed regulation is to amend Chapter 624 of the Nevada Administrative Code to add four new subclassifications concerning fountains and water features; telecommunications towers; conveyance of goods; and private fire hydrants. Proposed changes also amend existing language to clarify and streamline the language making it more consistent with current trade practices.

2. Either the terms or the substance of the regulations to be adopted, amended or repealed or a description of the subjects and issues involved.

The proposed regulation adds two new subclassifications to classification 'A'(General Engineering) relating to fountains and water features and telecommunications towers, adds one new subclassification to classification C-14 (Steel Reinforcing and Erection) concerning conveyance of goods, and adds one new subclassification to classification C-41 (Fire Protection) concerning private fire hydrants. Additional amendments seek to clarify and streamline language within classifications A (General Engineering), C-2 (Electrical), C-3 (Carpentry), C-4 (Painting & Decorating), C-15 (Roofing & Siding), C-16 (Finishing Floors), C-36 (Installing Urethane), C-38 (Installing Equipment used with Liquefied Petroleum and Natural Gas), and NAC 624.580 (License to build upon or improve own commercial property). A copy of the proposed regulations may be obtained by visiting our website at www.nscb.nv.gov or writing to the Board's offices.

- 3. The estimated economic effect of this proposed regulation on the business which it is to regulate and on the public.
 - (a) Adverse and beneficial effects.

The adoption of the regulation should not result in any adverse economic effects on either the licensee or the general public. Many of the proposed changes to subclassifications expand upon existing authorities of the licensee with regard to current products and industry standards.

(b) Both immediate and long-term effects.

The immediate and long term effect of implementing the change should be beneficial since it will more accurately explain the work allowed under the classification.

- **4.** The estimated cost to the agency for the enforcement of the proposed regulation. Cost to the agency should be minimal.
- 5. A description of and citation to any regulations of other states or local governmental agencies which the proposed regulation overlaps or duplicates and a statement explaining why the duplication and overlapping is necessary.

The proposed regulation does not overlap or duplicate any regulation.

6. If the regulation is required pursuant to federal law, a citation and description of the federal law.

- 8. Whether proposed regulation establishes a new fee or increases an existing fee. The regulation does not establish a new fee or increase an existing fee.

Written submissions must be received y the Board five days prior to the scheduled workshop. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the board may proceed immediately to act upon any written submissions.

A copy of this notice and the regulations to be adopted, amended or repealed will be on file at the State Library, 100 Stewart Street, Carson City, Nevada, for inspection by members of the public during business hours. This notice and the text of the proposed regulation will be available in the State of Nevada Register of Administrative Regulations, which is prepared and published monthly by the Legislative Counsel Bureau pursuant to NRS 233B.0653, and on the Internet at www.leg.state.nv.us. Copies of this notice and the proposed regulation will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if deemed necessary.

Upon adoption of any regulation, the board, if requested to do so by an interested person, either before adoption or within 30 days thereafter, shall issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against its adoption.
