### MINUTES OF THE REGULATION HEARING BEFORE THE NEVADA STATE CONTRACTORS BOARD FEBRUARY 15, 2024

#### CALL TO ORDER:

Ms. Grein indicated that the notice of the hearing was posted in compliance with NRS 233B at the Board's website, Nevada Public Notice website, State Library and Archives, Nevada's Regulation Notices website, both offices of the State Contractors Board in Reno and Las Vegas; emailed to persons who expressed interest in being kept informed of the Board's meetings.

Ms. Grein explained the purpose of the hearing is to receive comments from interested parties concerning the proposed regulation identified as LCB file R050-23. The purpose of the proposed regulation is to amend Chapter 624 of the Nevada Administrative Code to consolidate duplicate license classifications in the trade of wrecking.

A workshop was held on February 1, 2024.

No one was present to offer public comment. No written comments were received.

Ms. Grein stated that the Board will consider adoption of the regulation on February 22, 2024. The hearing was adjourned at 1:08 p.m.
