BUILD WITH YOU CONSTRUCTION, LICENSE NO. 43690

Hearing Officer Clark found Patrick Benjamin McKinnish, Owner, dba Build with You Construction, license number 43690 guilty of violating NRS 624.3017(1) substandard workmanship; NRS 624.3013(5), as set forth in NRS 624.700(3)(a) failure to comply with the Board's Notice to Correct; NRS 624.302(5) failure or refusal to cooperate in an investigation; NRS 624.3013(5) failure in any material respect to comply with the provisions of this chapter or the regulations of the Board; NRS 624.3013(3) failure to establish financial responsibility. The Licensee was found guilty of the First, Second, Third, Fourth and Fifth Causes of Action with no fines imposed. Investigative costs were assessed in the amount of \$1,333.00. Licensee shall reimburse the Roaldson's \$1,454.00. Costs and reimbursement to the Roaldson's are to be paid within 90 days or license number 43690 will be automatically revoked. The license shall remain suspended. Upon application for reactivation of license number 43690, licensee shall provide a current financial statement and a new bond to the Board.
