1. FINANCIAL RESPONSIBILITY HEARING:

FLOOR TECH INC. LICENSE NO. 77466

INNOVATIVE LIGHTWEIGHT & WATERPROOFING, LICENSE NO. 77459

Licensee was present and was represented by Jeff Spencer, Esq.

Hearing Officer Cavin approved both licenses each with a \$10,000 limit and \$2,000 bond.

2. RE-ACTIVATE INACTIVE LICENSE HEARING:

Licensee was present.

Hearing Officer Cavin approved the license, limited to only working on property owned by licensee. The monetary license limit was reduced to \$200,000.

3. FINANCIAL RESPONSIBILITY HEARING: J S C PAINTING INC, LICENSE NO. 43327A

Licensee was not present.

Hearing Officer Cavin suspended license number 43327A immediately and found licensee guilty of violating of NRS 624.3013(3) failure to establish financial responsibility. Respondent must pay a fine in

the amount of \$500.00; investigative fees in the amount of \$475.38. Respondent has 30 days to provide a current financial statement supporting the license limit and pay the fine and fees or license will automatically be revoked.

Hearing Officer Cavin found license number 77836 guilty of violating of NRS 624.3013(3) failure to establish financial responsibility and NRS 624.302(5) failure to comply. License number 78218 is revoked. Respondent must pay a fine in the amount of \$750.00; investigative fees in the amount of \$475.38.

<u>6. FINANCIAL RESPONSIBILITY HEARING:</u> REYNA HEATING & AIR CONDITIONING LLC, LICENSE NO. 78286

Licensee was present.

Hearing Officer Cavin suspended license number 78286 and found licensee guilty of violating of NRS 624.3013(3) failure to establish financial responsibility and NRS 624.302(5) failure to comply. Respondent must pay a fine in the amount of \$750.00; investigative fees in the amount of \$475.38 and provide a current financial statement that meets the requirements of staff within 30 days. If Respondent fails to pay the fine, fees and provide a current financial statement within 30 days, the license will automatically be revoked.
