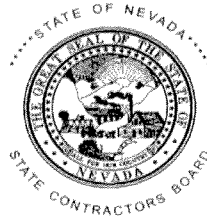

ADJUDICATING LAW JUDGE: BRUCE ROBB

1. DISCIPLINARY HEARING:

ADVANCED GREEN BUILDERS

Licensee was not present, but was represented by Philip Kreitlein, Esq.

At the request of the licensee, this matter was continued to the June 11, 2014 hearing.

2. FINANCIAL RESPONSIBILITY HEARING:

FOCUS 1 AIR QUALITY SOLUTIONS, LICENSE NO. 77601

Licensee was present.

Adjudicating Law Judge Robb found Respondent guilty of violating NRS 624.3013(3) failure to establish financial responsibility and NRS 624.302(5) failure to comply. Respondent must pay a fine of \$250.00 and investigative fees in the amount of \$504.98. Respondent must pay the fine and fees within ten (10) days from May 7, 2014. Respondent must submit to a financial review in 2015.

3. FINANCIAL RESPONSIBILITY HEARING:

MEYER & LUNDAHL MANUFACTURING CO, LICENSE NO. 77601

Licensee was present.

Adjudicating Law Judge Robb suspended license number 77601 for a period of six (6) months to provide the requested documents to the Board. The monetary license limit is reduced to \$245,000.00.

4. FINANCIAL RESPONSIBILITY HEARING:**SOUTHWEST BUILDERS LLC, DBA ALL AMERICAN BUILDERS, LICENSE NO. 72606**

Licensee was not present.

Adjudicating Law Judge Robb found Respondent guilty of violating NRS 624.3013(3) failure to establish financial responsibility. License number 72606 is revoked. Respondent must pay a fine of \$250.00 and investigative fees in the amount of \$484.12 within thirty (30) days from May 7, 2014.

5. FINANCIAL RESPONSIBILITY HEARING:**KENNETH WESLEY THOMPSON DBA, KENNY THOMPSON CONSTRUCTION, LICENSE NO. 77711**

Licensee was not present.

Adjudicating Law Judge Robb found Respondent guilty of violating NRS 624.3013(3) failure to establish financial responsibility, NRS 624.302(5) failure to comply and NRS 624.3013(4) failure to maintain bond. License number 77711 is revoked. Respondent must pay a fine of \$1,500.00 and investigative fees in the amount of \$475.38 within thirty (30) days from May 7, 2014.

6. FINANCIAL RESPONSIBILITY HEARING**DR. GRID WORKS INC, LICENSE NO. 60291**

Licensee was not present.

Adjudicating Law Judge Robb found Respondent guilty of violating NRS 624.3013(3) failure to establish financial responsibility and NRS 624.302(5) failure to comply. License number 60291 is revoked. Respondent must pay a fine of \$1,500.00 and investigative fees in the amount of \$618.28 within thirty (30) days from May 7, 2014.

7. REACTIVATIVE DENIAL HEARING:**POWER QUALITY TECHNICAL SERVICES INC, LICENSE NO. 49499**


Licensee was present.

Adjudicating Law Judge Robb approved license number 49499 for reactivation. Joseph C. Dietrich is allowed to withdraw his personal indemnification and the monetary license limit is reduced to \$10,000.00.
