ADJUDICATING HEARING OFFICER: JAN B. LEGGETT

1. FINANCIAL RESPONSIBILITY HEARING:

CHAMPION FLOORS TO GO, LICENSE NO. 23306

Licensee was present with counsel William B. Cherry, Jr., Esq.

Hearing Officer Leggett ordered the license remain in renewal pending status. Respondent shall provide satisfaction of the tax liens to staff within 120 days. If the liens have been satisfied, the license will be reactivated. If the liens have not been satisfied, the matter will be set for hearing.

2. FINANCIAL RESPONSIBILITY HEARING

J LINCOLN COMPANY, LICENSE NO. 78603

Licensee was present.

Respondent shall provide to staff a copy of the Offer and Compromise made with the IRS, proof of payments made to the IRS and the status of his case with the "tax defense partners" by April 15, 2015 or license will automatically be suspended.

3. FINANCIAL RESPONSIBILITY HEARING

Hearing Officer Leggett ordered the license remain active. Respondent shall provide a current financial statement or financial information from an indemnitor that satisfies staff within 30 days or license will automatically be suspended.

4. FINANCIAL RESPONSIBILITY HEARING

DUPURE INTERNATIONAL INC. LICENSE NO. 78643

Licensee was not present.

Hearing Officer Leggett found Respondent guilty of violating of NRS 624.3013(3) failure to establish financial responsibility and NRS 624.302(5) failure to comply. License number 78643 is revoked. Respondent must pay a fine in the amount of \$750.00 and investigative fees in the amount of \$475.30.

5. FINANCIAL RESPONSIBILITY HEARING

TRUE LINE BUILDERS LLC., LICENSE NO. 78625

Licensee was present.

Hearing Officer Leggett ordered license remain active. Respondent shall provide a current CPA prepared reviewed or audited financial statement supporting the license limit within 60 days or the license will automatically be suspended.
