Licensee Drew Levy was not present but was represented by Georlen K. Spangler, Esq. at the hearing.


Licensees Summerlin Energy, LLC, Marisa Corinne Bankey and Sean Francois Melaerts were not present at the hearing nor represented by counsel.

**ADJOURNMENT**


There being no further business to come before the Board, the meeting was adjourned by ALJ Pro at 9:04 a.m.
