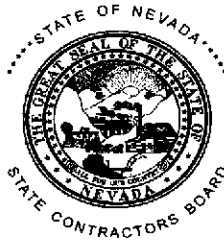

Hearing Officer Leggett found the Respondent Esprit Construction, license number 47286 guilty of violating NRS 624.3015(2) by bidding or contracting for a sum for one construction contract or project in excess of the limit placed on the license by the Board; NRS 624.3015(4) knowingly entering into a contract with a contractor while that contractor is not licensed; NRS 624.3014(2)(b) and (d), by: (b) Combining or conspiring with an unlicensed person to perform an unauthorized act; (d) Acting as an agent, partner or associate of an unlicensed person; NRS 624.3014(2)(a) aiding or abetting an unlicensed person to evade the provisions of this chapter; NRS 624.3013(3) by failing to establish financial responsibility. Licensee shall pay an administrative fine of \$1,000.00 for the First Cause of Action,

\$1,000.00 for the Second Cause of Action, \$100.00 for the Third and Fourth Causes of Action and \$500.00 for the Fifth Causes of Action for a total fine in the amount of \$2,700.00; reimburse to the Board investigative fees of \$2,461.00. Fines and fees are to be paid within sixty (60) days of the August 10, 2016 hearing or license number 47286 will automatically be suspended.

Hearing Officer Leggett found the Respondent guilty of violating NRS 624.3013(3) failure to establish financial responsibility and NRS 624.302(5) failure to comply with the Board and was fined \$750.00. License number 79897 is suspended until the fines, fees and a financial statement is provided. If Respondent does not comply, the license will automatically be revoked. Respondent must reimburse the Board's investigative fees in the amount of \$474.81.

BURNS & MCDONNELL ENGINEERING COMPANY INC, LICENSE NOS. 80623, 80628


Licensee was not present.

ADJOURNMENT


There being no further business to come before the Board, the meeting was adjourned by Hearing Officer Leggett at 9:45a.m.
