- Review of Monthly Department Statistics

### Licensing Division:

- Received 256 new license applications and 508 change applications;
- Issued 172 new licenses;
- Approved 79 Financial Reviews; and
- Processed 1,048 inactive and active license renewal applications.

### Compliance (CIU) Division:

- Opened 199 complaints and closed 250;
- Issued 40 Administrative Citations;
- Held 8 Disciplinary Hearings; and
- Closed 37 Recovery Fund Cases, with approximately \$70,000 being distributed among 32 homeowners.

### Criminal (SIU) Division:

- Opened 163 complaints and closed 187 complaints;
- Issued 2 administrative citations for unlicensed contracting, and 16 court filings; and
- Recorded 32 misdemeanor convictions, 3 gross misdemeanor convictions, and 5 felonies during the period.

Additional Board Activities:

- Participated in a Nevada Organization of Building Officials meeting and the Commission on Construction Education meeting.
- Held a regulation workshop and hearing on Legislative Counsel Bureau file T008-16.
- Executive Officer attended the Southern Nevada Homebuilders Association Installation of Officers and Awards Banquet.
- Public Information Office met with representatives from Nevada Women Magazine and Univision to discuss media opportunities.
- Veteran staff and Board members were honored, and the Board extended its appreciation to employees at two separate events.
