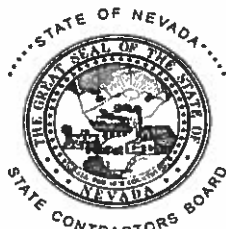

Hearing Officer Cavin found the Respondent guilty of violating NRS 624.3013(3) failure to establish financial responsibility and NRS 624.302(6) failure to comply with a written request by the Board and NRS 624.3013(4) failure to maintain bond. License number 80756 is suspended until Respondent provides a current financial statement, change of address form along with any other documents requested by staff, pay a fine in the amount of \$1,000.00 and reimburse the Board's investigative fees in the amount of \$477.63 within thirty (30) days from June 7, 2017, the license will be reactivated. If Respondent fails to provide the requested documents, pay the fines and fees within thirty (30) days of June 7, 2017, license number 80756 will automatically be revoked.


**ADJOURNMENT**
