MINUTES OF THE MEETING

November 13, 2019

CALL TO ORDER:

Noah Allison, Esq. called the meeting of the State Contractors Board to order at 8:30 a.m., Wednesday, November 13, 2019, State Contractors Board Reno, Nevada. Exhibit A is the Meeting Agenda and Exhibit B is the Sign In Log.

1. DISCIPLINARY HEARING:

LYNN HOUSE MOVERS LLC, License No. 79860

The licensee was present at the hearing but not represented by counsel.

ALJ Allison found the Respondent Lynn House Movers LLC, license number 79860 guilty of one (1) violation of NRS 624.3015(1) acting in the capacity of a contractor beyond the scope of the license; one (1) violation of NRS 624.301(4) willful failure or refusal without legal excuse on the part of a licensee as a contractor to prosecute a construction project or operation with reasonable diligence, thereby causing material injury to another and one (1) violation of NRS 624.3013(5), pursuant to NAC 624.700(3)(a) failure to comply with the Boards Notice to Correct. License number 79860 is placed on probation. Respondent was assessed a fine of \$2,000 for the First Alleged Violation, a fine of \$500 for the Second Alleged Violation and a fine of \$500 for the Third Alleged Violation for total fines of \$3,000 and investigative costs of \$1,913. Fines and Investigative costs are to be paid within sixty (60) days of the November 13, 2019 hearing or

license number 79860 will automatically be suspended. Licensee must not enter into any verbal agreements and must provide any and all future contracts in writing and submit them to the Board every 6 months for a 2 year period.

2. DISCIPLINARY HEARING – RECONSIDERATION HEARING OF DECISION AND ORDER DATED SEPTEMBER 5, 2019

CR CONSTRUCTION dba, C 1 CONSTRUCTION, LICENSE NOS. 78295, 80606

The licensee was not present at the hearing.

The following Agency Exhibit was entered:

Exhibit 1 – Amended Complaint

ALJ Allison found Respondent guilty of one (1) violation of NRS 624.3013(5) by failing to notify the Board if any change occurs in a licensee's address or personnel which affects the accuracy of the statement in the application upon which its license is based, shall report the change in writing to the Board within 30 days after the change occurs as required by NAC 624.640(3), one (1) violation of NRS 624.302(5) failure or refusal to respond to a written request from the Board or its designee to cooperate in the investigation of a complaint. Pursuant to NRS 624.285(1)(4), one (1) violation of NRS 624.3016(7) misrepresentation or the omission of a material fact, or the commission of any other fraudulent or deceitful act, to obtain a license and one (1) violation of NRS 624.3013(3) by failing to establish financial responsibility. License numbers 78295 and 80606 remain revoked. Respondent was assessed a fine of \$50 each for the Fourth and Fifth Alleged Violations, a fine of \$250 for the Sixth Alleged Violation and a fine of \$500 for the Seventh Alleged Violation for total fine of \$850. Respondent shall pay fines, fees and provide a compliant financial statement prior to relicensure.


