ALJ Allison found Respondent guilty of one (1) violation of NRS 624.30165(2) making false or misleading statements or representations of a material fact to induce another person to use the services of the contractor; one (1) violation of NRS 624.3016(1) fraudulent or deceitful acts committed in the capacity of a contractor; one (1) violation of NRS 624.302(7) failure to comply with an order of the Board; one (1) violation of NRS 624.3013(5), as set forth in NAC 624.640(5) failure to include the license number and monetary license limit on contract; and one (1) violation of NRS 624.3013(3) failure to establish financial responsibility. Respondent was assessed a fine of \$1,000.00 for each of the First and Fifth Alleged Violations; a fine of \$3,000.00 for the Second Alleged Violation; a fine of \$4,500.00 for the Third Alleged Violation; a fine of \$250.00 for the Fourth Alleged Violation for total fines of \$9,750.00 and investigative costs of \$2,838.00. License number 70415, Anthony Enterprises, Inc., dba Anthony Roofing & Waterproofing was revoked. Respondent is required to make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund plus pay the fines and investigative costs prior to consideration of future licensure.

ALJ Allison found Respondent guilty of one (1) violation of NRS 624.3017(1) workmanship not commensurate with the standards of the trade in general; one (1) violation of NRS 624.3013(2) contracting for a sum in excess of license limit; one (1) violation of NRS 624.3013(5), as set forth in NAC 624.640(5) failure to include the license number and monetary license limit on contract; and one (1) violation of NRS 624.3013(3) failure to establish financial responsibility. The Second, Fourth, Sixth and Seventh Alleged Violations were dismissed. Respondent was assessed a fine of \$500.00 for each of the First and Eighth Alleged Violations; a fine of \$1,000.00 for the Third Alleged Violation; a fine of \$100.00 for the Fifth Alleged Violation for total fines of \$2,100.00 and investigative costs of \$3,871.00. Respondent is to provide a completed bank verification form within five (5) days of the February 19, 2020 hearing or license number 72107, Renovations of Las Vegas, Inc. shall be suspended. Respondent was found guilty of one (1) violation of NRS 624.3017(1) workmanship not commensurate with the standards of the trade in general; one (1) violation of NRS 624.3013(5), as set forth in NAC 624.700(3)(a) failure to comply with the Board's Notice to Correct; one (1) violation of NRS 624.3015(1) acting in the capacity of a contractor beyond the scope of the license; one (1) violation of NRS 624.3015(2) contracting for a sum in excess of license limit; one (1) violation of NRS 624.3013(5), as set forth in NRS 624.520(1) failure to provide Residential Recovery Fund notice to owner; one (1) violation of NRS 624.302(6) failure to comply with a written request by the Board; one (1) violation of NRS 624.3013(5), as set forth in NAC 624.640(5) failure to include its license number and monetary license limit on its contracts; and one (1) violation of NRS 624.3013(3) failure to establish financial responsibility. Respondent was assessed a fine of \$1,000.00 for each of the First, Second, Third, Fourth, Fifth, Sixth, Seventh and Eighth Alleged Violations for total fines of \$8,000.00 and investigative costs of \$1,183.00. License number 77634, Big Dog Custom Works, LLC was revoked. Respondent is required to make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund plus pay the fines and investigative costs prior to consideration of future licensure.
