Michael Moffitt and Janice Moffitt were not present for the hearing. The Hearing Officer admitted evidence into the record, which included the Respondent's bankruptcy filing and death certificate of Roy Moffitt. The Hearing Officer ordered the immediate revocation of license numbers 55544, 81171, and 68494 and found guilt on causes of actions 1-23 with a \$46,000 fine and investigative costs in the amount of \$400.64 in addition to reasonable attorney fees and hearing officer fees recoverable pursuant to NRS 622.400, and the Board's investigative costs pursuant to NRS 624.341(2)(c).

Building Department by the end of the day on May 5, 2022 and to provide a compliant financial statement to the Board. This matter was continued to June 1, 2022.
