### MINUTES OF THE HEARING BEFORE THE NEVADA STATE CONTRACTORS BOARD JUNE 2, 2022

CALL TO ORDER:

The hearing for LCB File No. R034-22 was called to order at 8:30 a.m. on Thursday, June 2, 2022 at the offices of the State Contractors Board, 8400 West Sunset Road, Suite 150, Las Vegas, Nevada and 5390 Kietzke Lane, Suite 102, Reno, Nevada. Exhibit 1 is the Notice of Intent to Act Upon a Regulation and a copy of the proposed regulation.

Ms. Grein indicated that the notice of the hearing was posted in compliance with NRS 233B at the Board's website, Nevada Public Notice website, State Library and Archives, Nevada's Regulation Notices website, both offices of the State Contractors Board in Reno and Las Vegas; emailed to persons who expressed interest in being kept informed of the Board's meetings.

Ms. Grein explained the purpose of the hearing is to receive comments from interested parties concerning the proposed regulation identified as LCB file R034-22. The proposed regulation is to amend Chapter 624 of the Nevada Administrative Code by adding a new subclassification for Residential Remodeling. The purpose of this classification is to provide an opportunity for licensure to companies that solely perform residential remodeling work and who may not have the experience or the desire to perform residential and small commercial construction as provided for in the B2-Residential & Small Commercial classification.

No one was present to offer public comment. No written comments were received.

Ms. Grein stated that the Board will consider adoption of the regulation on June 16, 2022.

The hearing was adjourned at 8:32 a.m.
