  - Hosted 2 online Business Assistance Programs with 17 participants in attendance.
- Investigations Department:
  - Received 231 compliance complaints and 108 criminal complaints;
  - o 15 Disciplinary Hearings were held in the months of November and December.
  - o Issued 38 Cease and Desist Orders to unlicensed contractors; and
  - Opened 10 Recovery Fund claims; and held one Recovery Fund meeting where 4 claims were considered and 2 were awarded a total of \$36,940.25.
