Respondent to provide the Board with a compliant financial statement within 30 days. The Administrative Law Judge further finds Respondent in violation of allegation #1 with a fine of \$2,000; #2, with a fine of \$2,000; #3 with a fine of \$250 and #5 with a fine of \$1,000. Administrative Law Judge further ORDERS that Respondent is ordered to pay NSCB fees and costs within 30 days and if not paid, immediate revocation of license.

Due to a preponderance of evidence, the Administrative Law Judge grants Motion for Default against Respondent and ORDERS that Respondent is not permitted to present new testimony or evidence. The Administrative Law Judge further finds that violations #1, 2, 3, 4, 5 and 6 are hereby dismissed without prejudice regarding homeowners John & Laurie Thomas. The Administrative Law Judge finds Respondent in violation of allegation #7 with a fine of \$5,000, #8 with a fine of \$5,000, #10 with a fine of \$10,000, #11 with a fine of \$2,000, #12 with a fine of \$2,000, #13 and #15 with a combined fine of \$10,000, #14 with a fine of \$2,000, #16 with a fine of \$10,000, #17 with a fine of \$5,000, #20 with a fine of \$10,000, #19 with a fine of \$5,000, #20 with a fine of \$10,000, #21 with a fine of \$5,000, #22 with a fine of \$10,000 and #23 with a fine of \$2,000. The Administrative Law Judge further ORDERS that the Respondent pay NSCB fees and costs and to reimburse Complainant Jackson \$600,000, and to further reimburse the NSCB Residential Recovery Fund. These reimbursement monies have to be paid in full before Respondent can apply for a new license with any company.
