Appearances by Respondent, Miguel Gutierrez who appeared with counsel, Edgar Smith, Esq.; Complainant Gloria Diaz and her son; Jack Juan, Prosecutor, Terry Wike, Compliance Supervisor and Irene Elicerio, Compliance Investigator. The Administrative Law Judge (ALJ) reminded everyone of the previous facts and testimony from the July 19, 2023 hearing, and the hearing resumed with one witness.
