Carson, President, license number 51260 guilty of Three (3) violations of NRS 624.3017(1) substandard workmanship; Three (3) violations of NRS 624.3013(5), as set forth NAC 624.700(3)(a) failure to comply with the Board's Notice to Correct; Four (4) violations of NRS 624.302(5) failure to cooperate in an investigation; Two (2) violations of NRS 624.3011(1)(b)(1) willful or deliberate disregard and violation of the building laws of the State or of any political subdivision thereof; NRS 624.3013(3) failure to establish financial responsibility; NRS 624.302(6) failure to comply with a written request from the Board for information or records; NRS 624.3013(5), as set forth in NAC 624.640(5) each licensee shall include in all bids he submits or contracts he enters into for construction work within this state, the number of his license and monetary limit placed upon his license; NRS 624.3013(5), as set forth in NRS 624.520(1) failure to provide Residential Recovery Notice to owner; NRS 624.3011(1)(b)(4) willful or deliberate disregard and violation of the laws of this state regarding industrial insurance; NRS 624.3016(7) misrepresentation or omission of a material fact. Hearing Officer Zech found Respondent Sports International, Inc., Lawrence S. Zale, President, license number 53551 guilty of violation of NRS 624.3012(2) failure to pay money when due for materials or services rendered; NRS 624.3013(3) failure to establish financial responsibility; NRS 624.302(6) failure to comply with written request from the Board for information or records; NRS 624.302(5) failure to cooperate in an investigation. Mr. Zale was assessed a fine of \$1,000.00 for the First, Second, Third and Fourth Causes of Action for a total fine of \$4,000.00. The Fifth Cause of Action was dismissed. Fine was stayed for One (1) year after the license is reactivated with the stipulation that if there are no complaints filed within that time the fines will be cancelled. Investigative costs were assessed in the amount of \$1,599.00 and are to be paid within 90 days after the license is reinstated or license number 53551, Sports International, Inc. will be automatically Suspended. Mr. Zale is to continue payment plan with Labor Express Temp Service.

License number 50647, Andy J. Kay, dba Legacy Construction Enterprises is Suspended until the Board receives a financial statement prepared by a Certified Public Accountant that supports the monetary limit on the license. If the financial statement does not support the monetary license limit, Respondent will go before the Board for financial review. Mr. Kay was assessed a fine of \$1,000.00 for the First Cause of Action. The Second Cause of Action was dismissed. Investigative costs were assessed in the amount of \$2,017.00. Mr. Kay is to make restitution to C & W Enterprises, Inc. in the amount of \$12,550.05. Fines, costs and restitution is to be paid within 30 days from March 29, 2005 or license number 50647, Andy J. Kay, dba Legacy Construction Enterprises will automatically be Suspended. A Permanent Letter of Reprimand will be placed in the Respondent's file for the Third and Fourth Causes of Action. Hearing Officer Zech found Respondent Bobby Von Luker, Jr., dba Pacific Concepts, license number 35736 guilty of Two (2) violations of NRS 624.3017(1) substandard workmanship; Two (2) violations of NRS 624.3013(5), as set forth in NAC 624.700(3)(a) failure to comply with the Board's Notice to Correct; Three (3) violations of NRS 624.302(5) failure to cooperate in an investigation; NRS 624.301(4) willful failure to refusal without legal excuse to prosecute with reasonable diligence, causing material injury to another; Two (2) violations of NRS 624.3015(2) bidding to contract for a sum for one construction contract in excess of the limit placed on the license by the Board; NRS 624.3013(3)

failure to establish financial responsibility; NRS 624.302(6) failure to comply with a written request from the Board for information or records; NRS 624.3013(5), as set forth in NAC 624.640(5) each licensee shall include in all bids he submits or contracts he enters into for construction work within this State, the number of his license and monetary limit placed upon his license; NRS 624.3016(6) failure to comply with NRS 624.600 which are required disclosure by general building contractors; NRS 624.301(1) abandonment; NRS 624.3013(5), as set forth in NAC 624.640(3) failure to notify the Board change of address or personnel within 30 days after the change occurs. License number 35726, Bobby Von Luker, Jr., dba Pacific Concepts will remain suspended until the Board receives a current financial statement prepared by a Certified Public Accountant. Mr. Von Luker, Jr. was assessed a fine of \$1,000.00 for the First, Second, Third, Fourth, Fifth, Sixth, Seventh, Ninth, Thirteenth, Fourteenth and Eighteenth Causes of Action for a total fine of \$11,000.00. The Sixteenth and Seventeenth Causes of Action were dismissed. Mr. Luker, Jr. is to make monetary restitution to Ms. Paige Haldeman and Ms. Mary Dickson or hire licensed contractors to complete workmanship issues. Fines, costs and restitution is to be paid within 90 days or license number 35736, Bobby Von Luker, Jr., dba Pacific Concepts will automatically be Revoked. Mr. Luker, Jr. is to provide current address and phone number to the Board. A Permanent Letter of Reprimand will be placed in the Respondent's file for the Eighth, Tenth, Eleventh, Twelfth, Fifteenth and Nineteenth Causes of Action. License number 46842, William M. Vint, Jr., dba Pacific Swimming Pool Plaster was Revoked. Mr. Vint, Jr. is required to pay full restitution to the damaged parties and reimburse the Board for Investigative costs of \$1,278.00 and any expenses that may be paid out of the Residential Recovery Fund.

Mr. Smyers was found guilty of violation of NRS 624.3017(1) substandard workmanship; NRS 624.3013(5), as set forth in NAC 624.700(3)(a) failure to comply with the Board's Notice to Correct; NRS 624.301(4) failure to comply with the terms of a construction contract or written warranty, thereby causing material injury to another; NRS 624.3011(1)(b)(1) willful or deliberate disregard and violation of the Building Laws of the State or of any political subdivision thereof; NRS 624.301(2) abandonment of a construction project when the percentage of the project completed is less than the percentage of the total price of the contract; NRS 624.301(1) abandonment without legal excuse of any construction project or operation engaged in or undertaken by the licensee as a contractor; NRS 624.3013(3) failure to establish financial responsibility; NRS 624.302(6) failure to comply with written request from the Board for information or records; NRS 624.3013(5), as set forth in NRS 624.520(1) failure to provide Residential Recovery Fund Notice to owner; NRS 624.302(5) failure to cooperate in an investigation. License number 49443, Desert Structures, Inc., dba Four Seasons Sunrooms was Revoked. Mr. Smyers is required to pay full restitution to the damaged parties and reimburse the Board for Investigative costs of \$2,995.00 and any expenses that may be paid out of the Residential Recovery Fund.

License number 53346, Asphalt Services of Nevada, Inc. was Revoked. Mr. Sweeney is required to pay full restitution to the damaged parties and reimburse the Board for Investigative costs of \$4,064.00 and any expenses that may be paid out of the Residential Recovery Fund.
