## BOARD TAKES DISCIPLINARY ACTION AGAINST TEN LICENSED CONTRACTORS

(*Henderson, NV*) – At its meeting on May 20, 2003 the Nevada State Contractors Board adjudicated cases against ten (10) licensed contractors.

*Tri-Shamrock Contractors, Inc.*, license number 38203 (Residential and Small Commercial) based out of Pahrump, Nevada was found in violation of Nevada Revised Statute 624 for substandard workmanship; and failure to comply with a notice to correct. The Board revoked the license of Tri-Shamrock Contractors Inc.

*Bartholomew Painting,* license number 41145 (Painting) based out of Pahrump, Nevada was found in violation of Nevada Revised Statute 624 for failure to pay for materials or services and failure to cooperate in the investigation of a complaint. Licensee was ordered to pay claimants. A permanent letter of reprimand was placed in licensee's file, and licensee was assessed the cost of investigation.

*Landgraphics Inc.*, license number 38139 (Landscape and Irrigation) and 52695 (Awnings) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for failure to pay for materials or services; failure to cooperate in the investigation of a complaint; failure to establish financial responsibility; and failure to keep in force a bond or cash deposit. The Board revoked the licenses of Landgraphics, Inc.

*John Tracy Nee dba Eagle Plastering,* license number 46703 (Lathing & Plastering), based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for substandard workmanship; failure to comply with a notice to correct; failure to include license number and monetary limit on a contract or proposal; and failure to provide required disclosures. The Board revoked the license of John Tracy Nee dba Eagle Plastering.

*Lynnette Rebecca Wells dba Total Land Concepts Landscape Design & Installation,* license number 51991 (Landscape Contracting) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for substandard workmanship; failure to comply with a notice to correct; failure to report to the Board a change in address or personnel; acting in the capacity of a

contractor beyond the scope of the license; failure to obtain the discharge or release of liens; failure to include license number and monetary limit on a contract or proposal; failure to provide required disclosures; failure to pay for materials or services; failure to establish financial responsibility; and failure to cooperate in the investigation of a complaint. The Board revoked the license of Lynnette Rebecca Wells dba Total Land Concepts Landscape Design & Installation.

**Brown Roofing,** license number 51325 (Roofing & Siding) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for failure to notify the Board of a petition for bankruptcy; failure to notify the Board of a change in address or personnel and failure to establish financial responsibility. The Board revoked the license of Brown Roofing.

*Wood & Tile Flooring Inc.*, license number 45868 (Wood Flooring) and *Gregory Adam Rybka dba Craftsmen Flooring*, license number 43512 (Tiling) based out of Las Vegas, Nevada were found in violation of Nevada Revised Statute 624 for failure to pay for materials or services; failure to establish financial responsibility; failure to cooperate in the investigation of a complaint; acting in the capacity of a contractor beyond the scope of the license; abandonment of a construction project; failure to comply with a written request from the Board; unlawful advertising; failure to include license number and monetary limit on a license or proposal; failure to provide required disclosures; and failure to keep in force a bond or cash deposit. The Board revoked the licenses of Wood & Tile Flooring Inc. and Gregory Adam Rybka dba Craftsmen Flooring.

The Nevada State Contractors Board is committed to protecting the public's health, safety, and welfare through licensing and regulation of the construction industry. Under Nevada Revised Statutes, a licensee is subject to disciplinary action by the Board for failure to comply with the requirements of the laws or regulations governing contractors. Violations may result in Board action against the contractor's license. The State Contractors Board has the power to regulate contractors and discipline licensees who violate NRS 624. Disciplinary action may consist of a fine of up to \$10,000 per offense, order corrective action, suspension, revocation or other action.

The Board will convene next in Reno, NV on June 3, 2003.
