## **Northern Nevada Homeowners Beware Of Scam Artists Offering Flood-Repair Assistance**

The Nevada State Contractors Board is warning Northern Nevada homeowners to beware of scam artists who offer “good deals” on roof repairs, painting and remodeling, and other home repairs, as a result of recent heavy rains and flooding caused by the overflowing Truckee River.

The Contractors Board Proactive Enforcement team in Northern Nevada is currently visiting the flood-ravaged areas of Reno, Sparks and Carlson City passing out literature and telephone contact numbers to report unlicensed activity. The team is also aggressively looking for unlicensed contractors preying on flood victims.

It is important to verify that a contractor is *licensed* by the State of Nevada before giving any money, or authorization for rain or flood-damage repairs. Beware of unlicensed contractors offering “good deals” or emergency repairs. These unlicensed contractors do not have bonds, liability insurance, and their workers are not covered by workman’s compensation benefits. If an unlicensed contractor or his employees are injured on your property, you may be liable for the injuries.

Many times these unlicensed contractors ask for cash payments up front, or before completing the work. Their written contracts are either non-existent, or generally written with no details of the work to be completed.

Any contractor who performs residential or commercial remodeling or repairs must have a valid Nevada State Contractors license and display it on his contract or invoice and must provide his pocket licensed contractor ID card if requested by the homeowner

Remember to always:

1. Hire *only* licensed contractors.
2. Check the contractor's license number by calling the Nevada State Contractors Board at (702) 486-1100 in Southern Nevada, or (775) 688-1141 in Northern Nevada.
3. Get three references and review past work.
4. Get at least three bids.
5. Get a written contract and do not sign anything until you completely understand the terms.
6. Pay 10% down or \$1,000, whichever is less, if a deposit is required.
7. Don't let payments get ahead of the work. Keep a record of all payments.
8. Don't make a final payment until you are satisfied with the job.

9. Don't pay cash.

10. Keep a job file of all papers relating to your project.

Contacting without a license in Nevada is a misdemeanor for the first offense, a gross misdemeanor for the second offense and a Class E felony for the third offense.

Homeowners should not use unlicensed contractors because their work is generally poor quality.

Homeowners who use unlicensed contractors are not eligible for the Residential Recovery Fund, and by law their contracts are null and void.
