## **GOVERNOR MAKES FOUR APPOINTMENTS TO CONTRACTORS BOARD**

**HENDERSON, Nev.** –Governor Sandoval has announced the appointment of Margaret Cavin and the reappointments of Kevin Burke, Nathaniel Hodgson, and Guys Wells to the Nevada State Contractors Board (NSCB) effective Nov. 1, 2011 thru Oct. 31, 2014. The board is comprised of seven members, six licensed contractors and one representative of the public.

“I would like to thank Governor Sandoval for his recent appointments to the Board,” expressed Margi A. Grein, NSCB executive officer. “Each member brings with them the skills and expertise necessary to help us continue on our journey to become a model regulatory agency. We look forward to the efforts that will be made throughout the duration of their term.”

Margaret Cavin was first appointed to the board in Jan. 2000 where she served three terms and was elected the first woman to serve as NSCB chair. She is the co-founder of J & J Mechanical Inc. with 30 years of experience in the construction industry, and served as President of the Nevada Chapter of the Associated General Contractors. Cavin is also the president of Friends of ACE High School, a tuition-free charter school in Reno that infuses construction- and engineering-career applicable methods into core high school curriculum.

Kevin E. Burke was first appointed to the board in Nov. 2008 and currently serves as NSCB chairman. He is president and chief executive officer of Burke Construction Group Inc. and is a licensed general engineering and general building contractor with more than 20 years experience. Burke also serves as a board member of the Associated General Contractors and the Las Vegas Chamber of Commerce Board of Trustees.

Nathaniel W. “Nat” Hodgson, III was first appointed to the board in Nov. 2008. He is the member and qualified individual of Green Serenity LLC, and served as the past president of the Southern Nevada Home Builders Association.

Guy M. Wells was first appointed to the board in Feb. 2006. He is president and chief executive officer of Wells Cargo Inc. and is a licensed general engineering and general building contractor with more than 30 years of construction experience. Wells is also an active member and officer of the Nevada Contractors Association.
