11 CONTRACTORS DISCIPLINED BY CONTRACTORS BOARD

HENDERSON, Nev. – At its Mar. 21 meeting, the Nevada State Contractors Board adjudicated cases involving 11 contractors.

Atlas Flooring, Inc., license numbers 50480, 52490, 52491 and 53669 (Finishing Floors, Tiling, Finish Carpentry Limited to Wood Flooring and Install Terazzo & Marble), based out of Henderson, Nev., was found in violation of Nevada Revised Statute 624 for substandard workmanship; failure to take appropriate corrective action. The licensee was fined \$4,000 and ordered to pay restitution to the homeowner. The licenses were revoked.

Hardy Construction, Inc., license number 19407B (General Engineering & General Building); **H C I Underground, LLC.**, license number 51357A (Excavating & Grading, Excavating, Grading Trenching & Surfacing, Wrecking Buildings, Sewers, Drains & Pipes, Paving Streets, Driveways & Parking Lots, Lines to Transmit Electricity, Pipeline & Conduits, Unclassified is Designated for Site Preparation for Playgrounds & Parks Only), based out of Las Vegas, Nev., were found in violation of Nevada Revised Statute 624 for failure to pay any money due for any materials or services rendered; failure to establish financial responsibility. The licensee was fined \$1,000 and ordered to pay investigative costs. The licensee shall submit a new application within 30 days of hearing. If a new license is not obtained within 90 days of hearing, license number 19407B shall be suspended. Fines and costs are due within 30 days of the hearing or licenses shall be suspended.

Neal & Sons Enterprises, LLC., dba Sage Construction, license number 62301 (Excavating & Grading, Sealing & Striping of Asphaltic Surfaces, Recycling Asphalt, Excavating, Grading, Trenching & Surfacing, Paving Streets, Driveways & Parking Lots, Fencing & Guardrails), based out of North Las Vegas, Nev., was found in violation of Nevada Revised Statute 624 for failure to pay any money due for any materials or services rendered; and failure to establish financial responsibility. The licensee was fined \$1,500 and ordered to pay investigative costs. The license was revoked.

Norpac Construction, LLC., license numbers 54755 and 54757 (Carpentry and Concrete Contracting), based out of Las Vegas, Nev., was found in violation of Nevada Revised Statute 624 for failure to establish financial responsibility. The licensee was fined \$500 and ordered to pay investigative costs. The licenses were revoked.

Silver City Construction, license number 13923 (General Building); **Geoffrey B Shaw, dba Silver City A C**, license number 25808 (Air Conditioning), based out of Las Vegas, Nev., were found in violation of Nevada Revised Statute 624 for failure to include the Residential Recovery Fund information on a contract or proposal; aiding or abetting an unlicensed person; and failure to establish financial responsibility. The licensee was fined \$1,600 and ordered to pay investigative costs. The licensee was also ordered to pay \$19,000 in restitution. The licenses were suspended until restitution is paid within 90 days of the hearing, and fines and costs are paid within 60 days of the hearing.

Benedict Construction, Inc., license number 18938A (General Building), based out of Las Vegas, Nev., was found in violation of Nevada Revised Statute 624 for failure to establish financial responsibility; and failure to keep in force a bond or cash deposit. Fines and costs were not assessed, as the licensee has filed for Chapter 13 Bankruptcy. The license was revoked.

Surfaceworks Custom Painting, LLC., license number 64103 (Painting), based out of Las Vegas, Nev., was found in violation of Nevada Revised Statute 624 for substandard workmanship; failure to take appropriate corrective action; failure to include the monetary license limit or license number on a contract or proposal; failure to keep in force a bond or cash deposit; contracting on a suspended or revoked license; and failure to establish financial responsibility. The licensee was fined \$3,250 and ordered to pay investigative costs. The license was revoked.

J C R Shotcrete, Inc., license number 49450 (Spraying Mix Containing Cement), based out of Las Vegas, Nev., was found in violation of Nevada Revised Statute 624 for failure to establish financial responsibility; and failure to respond to a written request from the Board. The licensee was fined \$1,000 and ordered to pay investigative costs. The license was revoked.

Vargas Electric, LLC., license number 58072 (Electrical Contracting), based out of Las Vegas, Nev., was found in violation of Nevada Revised Statute 624 for failure to establish financial responsibility; and failure to respond to a written request from the Board. The licensee was fined \$750 and ordered to pay investigative costs. The license was revoked.

Carc Plumbing, Inc., license number 74673 (Plumbing & Heating), based out of Las Vegas, Nev., was found in violation of Nevada Revised Statute 624 for failure to prosecute a construction project or operation thereby causing material injury to another; abandonment without legal excuse of any construction project; failure to respond to a written request from the Board; failure to include the monetary license limit or license number on a contract or proposal; failure to notify the Board of a change in personnel or address within 30 days of the change; and failure to establish financial responsibility. The licensee was fined \$3,250 and ordered to pay investigative costs. The license was revoked.

David J Dulfon, dba Daystar Construction, license number 73700 (Residential & Small Commercial), based out of Las Vegas, Nev., was found in violation of Nevada Revised Statute 624 for failure to establish financial responsibility; and failure to keep in force a bond or cash deposit. The licensee was fined \$1,000 and ordered to pay investigative costs. The license was revoked.

****The Business Review Program is one in which a contractor's business practices and regulatory compliance is examined by NSCB investigative staff. The program is a part of NSCB's proactive investigative efforts.**

The Nevada State Contractors Board is committed to protecting the public's health, safety, and welfare through licensing and regulation of the construction industry. Under Nevada Revised Statutes, a licensee is subject to disciplinary action by the Board for failure to comply with the requirements of the laws or regulations governing contractors. Violations may result in Board action against the contractor's license. The State Contractors Board has the power to regulate contractors and discipline licensees who violate NRS 624. Disciplinary action may consist of a fine of up to \$10,000 per offense, order corrective action, suspension, revocation or other action.
