



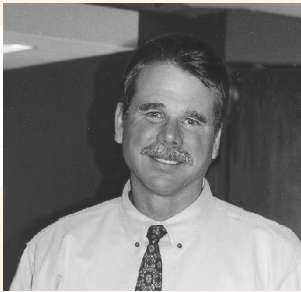

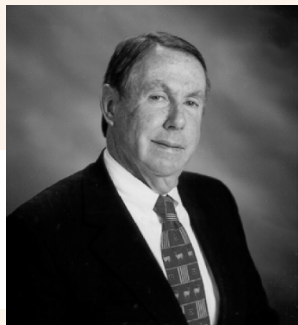

Nevada Contractor Examinations Revamped

The Nevada State Contractors Board has retained PSI Examination Services to administer the required testing for a contractor's license. PSI provides examinations through a network of computer examination centers throughout Nevada. These computerized tests are now offered daily at PSI's testing centers in Elko, Reno, North Las Vegas and Henderson.

The restrictions of paper and pencil testing have been eliminated, allowing a score report to be available immediately following testing. A candidate has three attempts to pass an examination in a 6-month period. A candidate who tests unsuccessfully must wait two weeks before retaking the examination.

According to PSI, the number of reference books has been streamlined, reducing the cost to the candidate and limiting study to the most relevant information.

A candidate can schedule an exam using a touch-tone phone by calling PSI 24 hours a day at (800) 733-9267. To schedule with a PSI registrar, call Monday through Friday, between 6:00 a.m. and 5:00 p.m., Pacific Time. If space is available in the examination site of choice, candidates may schedule an examination in as little as two business days prior to the examination date of choice.

A candidate may cancel and reschedule an examination

appointment without forfeiting the fee if the cancellation notice is received 3 full business days before the scheduled examination date.

There is no computer skills or typing skills needed to take the exam. Candidates will use fewer keys than on a touch-tone telephone.

Getting Paid: On Time Collections

We are frequently asked how a contractor could be assured of on time collection. We believe the question is one of general interest. Here are some ideas.

Nevada has laws that protect people that improve property, such as Mechanics' Liens, etc. However, there are other procedures in addition to liens or if for some reason, you are not able to protect your Mechanics' Lien rights.

Payment and Performance Bond

A payment and performance bond not only can be used to protect the owner, it can be a very strong selling tool for the contractor. A payment and performance bond is a financial guaranty on the contractor. In the marketplace where every contractor is pitching against another contractor, a payment and performance bond can be used to assure the owner that he is dealing with someone who has the financial stability to obtain such a bond.

Further, rather than telling the owner how much better you are than other contractors, or telling the owner how bad other contractors are, you can tell the

owner that there is a financial guarantee that work will be completed and that the subcontractors will be paid. This is a strong selling tool when owners are aware of horror stories.

Construction Control

Another type of protection for the consumer and others is the use of a construction control company. A construction control company is a specialized construction escrow. It is similar to other escrow companies, but deals in construction.

Typically, the owner will deposit the contract funds with the control company. A good joint control company actually goes out and physically inspects the job for progress, writes checks, and obtains lien releases. In this way, both the contractor and the owner are protected. The owner is protected in that there is a degree of assurance that a third party is inspecting the project and obtaining lien releases.

The contractor is protected in that there is an entity knowledgeable in construction that stands between him and the owner. There is less likelihood

that the owner will withhold the final payment since the owner has deposited the money in escrow.

How many times have owners withheld the final payment in an effort to extort something to which the owner is not entitled?

Invoice Frequently

Your contract should allow for frequent progress payments.

Frequent invoicing does several things. First, it helps your cash flow. Secondly, it allows the customer to understand that work has been done. Therefore the customer may not have the opportunity to later say, "I didn't know that you had done this." Payment by the owner would be a means of proving acceptance of the work paid for. Further, if there is going to be a dispute, you are better off having the breakdown occur early. If you are going to have problems collecting your money, it would be better that you are owed a little rather than a lot. Good Luck.

Safety: Protect Your Crew and Your Business

If you've nominated someone in your organization and deemed him the company safety expert (largely because he or she was the most willing), you may want to reconsider. In the construction industry, safety is very serious business. Your workers and your money could be in jeopardy if you don't take a close look at the execution of your safety plan.

According to OSHA statistics, one in every five workplace fatalities is in the construction industry. Despite this high fatality rate, construction can be a safe occupation when workers are aware of the hazards.

Randy Proby, safety consultant for SafetyPro of North Las Vegas and 20 year veteran of the construction industry warns against a lax attitude toward safety. He has seen many a good safety plan go unimplemented. "Some companies have a

good safety plan; it's just sitting on the shelf. You have to have someone to effectively put it into practice."

Safety also affects your bottom line. "A \$2,000 accident can end up costing the company \$18,000 in lost production time, medical bills, time off, replacements and training. The production starts going backwards. Conversely, when you're working in a safe manner, losses go down."

For example, an estimated 2.3 million construction workers (nationally), or 65% of the construction industry, work on scaffolds frequently. Protecting these workers from scaffold-related accidents would prevent 4,500 injuries and 50 deaths every year, at a savings for American employers of \$90 million in workdays not lost. Not only can your bottom line be affected by lost production time, but a surprise inspection by OSHA can also hit you in the bank account. Proby says that unfortunately many who contact him

have just been hit with fines that can be reduced by immediately complying with OSHA's safety standards.

"Even if you have a great safety plan, you really have to watch yourself. Just because it's not covered in the OSHA manual doesn't mean you can't be sited."

OSHA does provide information to help make sure that you are in line with its established standards. Industry specific "Compliance Assistance Tools" are available from OSHA's website at www.osha.gov.

5 Steps to a Safe Excavation

- 1. Survey and Mark.** Survey your proposed excavation site and make a list of affected facility owners and their requirements.
- 2. Call Before You Dig.** Call USA North two working days before you dig. Only facility owners who are members of the USA North program will be notified.
- 3. Wait the Required Time.** The two working days allow USA North to examine underground facility records and respond to you.
- 4. Respect the Marks.** Maintain facility marks for the duration of the job. If any of the utility markings are not reasonably visible, you must call USA North.
- 5. Dig With Care.** In Nevada, hand excavate within 30" of the outside diameter of the facility. Facilities that are in conflict with your excavation are to be located by hand and protected before power equipment is used.

SCATS Offers Free On-Site Safety Training

The Safety Consultation and Training Section (SCATS) of the Nevada Division of Industrial Relations offers free workplace safety assistance training to Nevada Employers to promote a safe and healthy workplace

SCATS is a state-run OSHA program that includes both enforcement and consultation divisions that are separately conducted. The mandated consultation service provides free safety surveys and the safety training. SCATS consultants will only provide their services at the request of the employer. The employer must be willing to correct any serious hazards based on OSHA and Nevada state regulations. The employer can stop the survey at any time if the necessary corrections become overwhelming.

Residential Recovery Fund

The 1999 Legislature established the Residential Recovery fund to provide homeowners with monetary relief in the event that the homeowner has suffered actual damages as a result of an act or violation of NRS 624 by a licensed Nevada contractor. The Board is required to evaluate claims and authorize payment to eligible damaged parties from the recovery fund. The law became effective October 1, 1999. All residential contractors are assessed an annual fee of \$100.00 to \$500.00 depending on the monetary license limit. Homeowners began filing claims against the fund on July 1, 2001. Claims received during FY 2001 - 2002 are as follows:

NSCB Reduces Bidder's Preference Certificate Renewal Fees

As of July 1, 2002, the fee for a Certificate of Eligibility for bidding on Public Works projects is down from \$700 to \$400. Bidder's Preference Certificates are available to Nevada Contractors who have been licensed in their classification for five years and have paid \$5,000 in taxes (sales and use tax and governmental service tax or a combination thereof) each consecutive twelve-month period for a period of 60 months immediately preceding

Contractor Ads Require a License Number Know the law and avoid penalties

Contractors who advertise are advised to ensure that their ads are complete with the appropriate license number for the work being represented. Whenever and wherever you advertise, whether it is in the phone book, newspaper, on you truck, or on your

business card, even on television, radio or the Internet - your license number must be included in that advertisement. Any advertisement lacking the appropriate license number is in violation of the law (NRS 624.720). It's a simple, yet very important step that will spare you the aggravation of possible penalties. If you have questions regarding placement of your license number on anything that represents your company, please call the Nevada State Contractors Board at 486-1100.



Masonry Inspection and Field Practices Seminar

The Nevada State Contractors Board and the Masonry Institute of America hosted the "Masonry Inspection and Field Practices," a two-day seminar that assisted individuals in need of the training to do a thorough and professional job in masonry inspection as well as those who wished to improve skills in the masonry trade and work toward ICBO certification in masonry.

John Chrysler, P.E. instructed the classes. Mr. Chrysler, Executive Director of the Masonry Institute, is a licensed contractor, a licensed civil engineer, and a certified structural masonry inspector who has been practicing in the masonry industry since 1968.

The course covered all aspects of masonry inspection including: general duties and responsibilities, quality and testing, choosing a lab, alternative testing methods, and IBC Code comparison.

Required Disclosures for General Contractors

The following disclosures are those required of general builders by Nevada Revised Statute 624 and Nevada Administrative Code 624.

NRS 624

624.600 A general building contractor shall provide in writing to the owner of a single-family residence with whom he has contracted:

1. The name, license number, business address and telephone number of:

- (a) All subcontractors with whom he has contracted on the project; and
- (b) All persons who furnish material of the value of \$500 or more to be used in the project.

2. A notice that a person described in subsection 1 may record a notice of lien upon the residence of the owner and any building, structure and improvement thereon pursuant to the provisions of NRS 108.226.

3. An informational form, whose contents must be prescribed by the board, regarding:

- (a) Contractors pursuant to chapter 624 of NRS; and
- (b) Mechanics' and materialmen's liens pursuant to chapter 108 of NRS.

NAC 624

GENERAL BUILDING CONTRACTORS: REQUIRED DISCLOSURES

NAC 624.693 Informational form regarding mechanics' and materialmen's liens. (NRS 624.100, 524.321) The informational form that a general building contractor is required to provide regarding mechanics' and materialmen's liens pursuant to paragraph (b) of subsection 3 of NRS 624.600 to the owner of a single-family residence with whom he has contracted must be as follows:

NOTICE TO OWNER

Pursuant to NRS 108.221 to 108.246, inclusive, a contractor, subcontractor, laborer, supplier of materials or other person or entity who:

- (1) Performs work or furnishes materials of the value of \$500 or more to improve the value of your property; and
- (2) Is not paid for the work or materials, has a right to place a lien on your property on which work was performed and to sue you in court to obtain payment.

NRS 624.520

RESIDENTIAL RECOVERY FUND

NRS 624.520 Contractor to notify owner of rights related to account; written statement; administrative fine for noncompliance. [Effective July 1, 2001.]

1. A residential contractor shall notify an owner with whom he contracts of the rights of the owner pursuant to NRS 624.400 to 624.560, inclusive including, without limitation, providing a written statement explaining those rights in any agreement or contract for qualified services. The written statement must be in substantially the following form:

RESIDENTIAL RECOVERY FUND

Payment may be available from the recovery fund if you are damaged financially by a project performed on your residence pursuant to a contract, including construction, remodeling, repair or other improvements . . .

"Honesty, Integrity and Hard Work will always pay off. There's nothing more you have than your word and you need to stick by it."
