**MINUTES OF THE WORKSHOP
BEFORE THE NEVADA STATE CONTRACTORS BOARD
HELD FEBRUARY 13, 2019**

The workshop was called to order at 9:00 a.m. on Wednesday, February 13, 2019 at the offices of the State Contractors Board, 2310 Corporate Circle, Henderson, Nevada and video-conferenced to the Reno office. Ms. Grein indicated that the notice of the workshop was posted in compliance with NRS 233B at the Paseo Verde Library, Sawyer State Building, Clark County Library, the Washoe County Courthouse, South Valleys Library, Reno City Hall; offices of the State Contractors Board in Reno and Henderson; on the agency's website and on the State of Nevada Public Notice website, the Nevada Register and mailed to persons who expressed an interest in receiving notice.

Ms. Grein explained the purpose of the workshop is to receive comments from interested parties concerning the proposed temporary regulation identified as LCB file T002-19. The purpose of the proposed temporary regulation is to amend Chapter 624 of the Nevada Administrative Code in order to:

- 1) Reduce barriers to licensure and provide greater portability by expanding and clarifying types of experience documentation needed for an applicant to become a license contractor; and,
- 2) Resolve conflict among various statutory schemes that can be reconciled and clarified with defining the employer-employee relationship as used in NRS Chapter 624

No one was present to offer public comment. No written comments were received. Ms. Grein stated that a hearing on the matter will be held February 22, 2019 at 9:00 a.m. at the same locations. The workshop was adjourned at 9:02 a.m.
