**1. DISCIPLINARY HEARING:** Aurora Glazing Solutions, Unlicensed

The licensee was present and represented by counsel. The Hearing Officer admitted evidence into the record and heard argument by the parties. The Hearing Officer revoked license 82933 and lifted the summary suspension on license numbers 9094A and 59339. The Hearing Officer then made preliminary decisions subject to finalization in a written Decision and Order. Matter continued to February 17, 2021.
