FINGERPRINTING INSTRUCTIONS

Pursuant to the provisions of the Nevada Revised Statute (NRS) 624.265 and the Nevada Administrative Code (NAC 624.681, all applicants are required to submit their fingerprints for the purpose of conducting a criminal background check.

ELECTRONIC FINGERPRINTS

Electronic fingerprint submissions can **ONLY** be accepted if obtained by an authorized Nevada-based vendor. **The State of Nevada does not accept fingerprints from out-of-state Live Scan vendors.**

STEP 1: Find a Nevada-based Live Scan Vendor: http://rccd.nv.gov/FeesForms/Fingerprints/

STEP 2: Take the enclosed Live Scan Fingerprint Verification Form to a Nevada-based Live Scan vendor for them to sign, date, and stamp. You must also complete and submit the Background Authorization Form included in your packet to the Nevada State Contractors Board.

STEP 3: All fingerprint fees will be collected by the Live Scan vendor.

PLEASE NOTE: It may take approximately one month for Nevada-based Live Scan fingerprint reports to be

submitted to the Board.

HARD COPY FINGERPRINT CARDS

Hard copy fingerprint submissions can be obtained in any state by an authorized vendor or law enforcement agency. Failure to follow the steps below could result in returned fingerprint cards, which may delay the processing of your application.

STEP 1: Obtain an **FD-258 Fingerprint Card** from the Nevada State Contractors Board or an authorized vendor or law enforcement agency.

STEP 2: You will be <u>required</u> to show proof of identity with a photo identification document in order to have your fingerprints taken.

STEP 3: The authorized vendor or law enforcement agency will take your fingerprints on one (1) fingerprint card. Ensure the following are complete during this process:

- □ Both you AND the person who took your fingerprints have signed the fingerprint card
- ☐ The complete date (00/00/00) has been entered
- All of the requested information has been completed (race, height, weight, POB, DOB, etc.)
 - Reason Fingerprinted: NRS 624.265
 - ORI: NV920470Z
 - MNU: 880598

STEP 4: You will need to submit the fingerprint card along with a <u>cashier's check or money order in the amount</u> of \$40.25 per person made out to the Nevada Department of Public Safety. Personal checks, company checks, cash and credit cards will not be accepted.

PLEASE NOTE: It may take several months before a FD-258 Fingerprint Card report is returned.
