

After sworn testimony by Respondent, Christopher Martin, and Max Kuennen, Criminal Investigator, **the Administrative Law Judge (ALJ) ORDERS that Respondent is found to be in violation of Allegations #1 and #2 and is to pay the original citation amount of \$1,950; in violation of Allegation #4 and fined in the amount of and \$500 for a total in fines of \$2,450. This amount is to be paid within 60 days of the Decision and Order. If Respondent wants to renew license numbers 53809A and 53809B, Respondent will need to have paid the fines of \$2,450 by the 60<sup>th</sup> day. If the fines are paid in full, Allegations #3, #5, #6 and #7 will be dismissed.**


